### **1. Number of places:**

1st call: 10 places

2nd call: 19 places

3rd call: 1 + remaining places

### **2. Minimum number of students for course opening:** Not applicable.

### **3. Application deadlines:**

1st call: 4th February to 29th March 2019

2nd call: 1st April to 15th July 2019

3rd call: 19th August to 6th September 2019

### **4. Admission requirements:**

1 - Applicants for admission to the PhD in Civil Engineering must be:

- a) Holders of the master's degree in Civil Engineering or any other appropriate, namely Environmental Engineering, Mechanical Engineering, Naval Engineering and Architecture, or legal equivalent;
- b) Holders of a bachelor's degree in Civil Engineering or any other appropriate, such as Environmental Engineering, Mechanical Engineering, Naval Engineering and Architecture, with at least 5 years of academic training in Higher Education, full time or equivalent degree obtained abroad;
- c) Holders of a school, scientific or professional curriculum that is recognized as attesting capacity to carry out this cycle of studies by the Academic Board of the Faculty of Sciences and Technology

of the University of Coimbra.

2 - The recognition referred to in subparagraphs b) and c) of paragraph 1 only allows access to the cycle of studies leading to a PhD Degree and does not grant its holder the recognition or equivalence to a Bachelor's or Master's Degree.

### 5. Selection criteria:

The score is on a scale of 0 to 20 and results from the application of the following formula:  $C = PA \times 2/3 + MS \times 1/3$ ,

being:

EM- Commitment, motivation and letters of recommendation (an interview or complementary information may be requested to clarify any doubts).

PA- Quality of the academic course and complementary training:

$PA = MC \times FB \times 3/4 + FC \times 1/4$

MC - grade average of degree;

FB - Prior training;

FC - Complementary training.

**NOTE:** Assessed applications that have a grade lower than 9.5 in one of the evaluation criteria will automatically become non-approved.

### 6. Required documentation:

1 – Motivation letter, explaining the reasons that lead the applicant to apply, if relevant according to the criteria established by the organic unit of the desired course (MANDATORY);

2 - Workload and programmes of curricular units if credits are to be requested (MANDATORY, unless the course of origin is taught at the University of Coimbra under the Bologna Process - after 2007/2008);

3 - 1st Letter of Recommendation;

4 - 2nd Letter of Recommendation;

5 - Certificate of Bachelor's degree with final course classification (diploma). If credits are to be requested, a certificate indicating all curricular units completed and classification obtained on each of the curricular units is required (MANDATORY, except if the primary course is a course taught at the University of Coimbra);

6 - Certificate of Master's degree with final classification (diploma). If credits are to be requested, a certificate indicating all curricular units completed and classification obtained on each of the curricular units is required (MANDATORY, except if the primary course is a course taught at the University of Coimbra);

7 - Curriculum Vitae (Europass format); (MANDATORY);

8 - Official document, issued by the institution awarding the degree, with certified grade (weighted average), (MANDATORY only for foreign candidates);

9 - Copy of Identity Document (MANDATORY only for foreign applicants).

NOTE: Admitted candidates who register and enroll in the course are required to present the original documents until the 31st of December in order to complete their individual student file.

The documents mentioned above must be certified by the local Portuguese consulate and / or legalized by the Apostille system under the Convention on Abolishing the Requirement of Legalization for Foreign Public Documents (better known as the Hague Convention), signed at The Hague, October 5, 1961, with the exception of documents issued by European Union Member-States. However, in case of doubt about the documentation presented, the aforementioned certification or submission of additional documentation may be requested to any applicant.

If the above-mentioned documents are in a foreign language other than Spanish, French or English, a translation must be presented. Translations must be duly certified by the competent authorities.

**7. Tuition fee:**
