# 4. Admission requirements:

1 - Applicants for admission to the Ph.D. in Pharmaceutical Sciences must be:

a) Holders of a master's degree or legal equivalent;

b) Holders of a bachelor's degree, holders of a particularly relevant academic or scientific curriculum that is recognized as adequate by the Academic Board of the Faculty of Pharmacy of the University of Coimbra;

c) Holders of a school, scientific or professional curriculum that is recognized as attesting ability to carry out this cycle of studies bby the Academic Board of the Faculty of Pharmacy of the University of Coimbra.

2 - The recognition referred to in subparagraphs b) and c) of paragraph 1 only allows access to the cycle of studies leading to a PhD Degree and does not grant its holder the recognition or equivalence to a Bachelor's or Master's Degree.

## 5. Selection criteria:

1. CV assessment: (Weighting 10/10)

1.1) adequacy of the 1st and 2nd cycle training to the PhD in Pharmaceutical Sciences of the Faculty of Pharmacy of the University of Coimbra:

1.1.1) recognition of academic merit in the 1st cycle course;

1.1.2) recognition of the adequacy of 2nd cycle course (or equivalent) to the requirements and profiles of the PhD programme;

1.2) recognition of scientific merit, namely publications, participation in projects and other scientific activities.

**NOTE**: Assessed applications that have a grade lower than 9.5 in one of the evaluation criteria will automatically become non-approved.

## 6. Required documentation:

1 – Motivation letter, explaining the reasons that lead the applicant to apply, if relevant according to the criteria established by the organic unit of the desired course (MANDATORY);

2 - Workload and programmes of curricular units if credits are to be requested (MANDATORY, unless the course of origin is taught at the University of Coimbra under the Bologna Process - after 2007/2008);

3 - 1st Letter of Recommendation (MANDATORY);

4 - 2nd Letter of Recommendation (MANDATORY);

5 - Certificate of Bachelor's degree with final course classification (diploma). If credits are to be requested, a certificate indicating all curricular units completed and classification obtained on each of the curricular units is required (MANDATORY, except if the primary course is a course taught at the University of Coimbra);

6 - Certificate of Master's degree with final classification (diploma). If credits are to be requested, a certificate indicating all curricular units completed and classification obtained on each of the curricular units is required (MANDATORY, except if the primary course is a course taught at the University of Coimbra);

7 - Curriculum Vitae (Europass format); (MANDATORY);

8 - Official document, issued by the institution awarding the degree, with certified grade (weighted average), (MANDATORY only for foreign candidates);

9 - Copy of Identification Document (MANDATORY only for foreign applicants).

NOTE: Admitted candidates who register and enroll in the course are required to present the original documents until the 31st of December in order to complete their individual student file.

The documents mentioned above must be certified by the local Portuguese consulate and / or legalized by the Apostille system under the Convention on Abolishing the Requirement of Legalization for Foreign Public Documents (better known as the Hague Convention), signed at The Hague, October 5, 1961, with the exception of documents issued by European Union Member-States. However, in case of doubt about the documentation presented, the aforementioned certification or submission of additional documentation may be requested to any applicant. If the above-mentioned documents are in a foreign language other than Spanish, French or English, a translation must be presented. Translations must be duly certified by the competent authorities.
