### **3. Application deadlines:**

1st call: 4th February to 29th March 2019

2nd call: 1st April to 15th July 2019

3rd call: 19th August to 6th September 2019

Extra call: 14th to 31st October 2019

### **4. Admission requirements:**

1 - Applicants for admission to the PhD in Sport Sciences must be:

a) Holders of a master's degree, or its legal equivalent;

b) Holders of a bachelor's degree, holders of a particularly relevant academic or scientific curriculum that is recognized as attesting capacity for the completion of this cycle of studies by the Scientific Committee of the Faculty of Sport Sciences and Physical Education;

c) Holders of a school, scientific or professional curriculum that is recognized as attesting capacity to carry out this cycle of studies by the Scientific Committee of the Faculty of Sport Sciences and Physical Education.

2 - The recognition referred to in subparagraphs b) and c) of paragraph 1 only allows access to the cycle of studies leading to a PhD Degree and does not grant its holder the recognition or equivalence to a Bachelor's or Master's Degree.

### **5. Selection criteria:**

- 1. Final grade of the academic degree(s), (10/20 Weighting);
- 2. Publications, (3/20 Weighting);
- 3. Participation in scientific meetings with work presentations, (3/20 Weighting);
- 4. Participation in research projects, (4/20 Weighting).

### **6. Required documentation:**

- 1 – Motivation letter, explaining the reasons that lead the applicant to apply, if relevant according to the criteria established by the organic unit of the desired course (MANDATORY);
- 2 - Workload and programmes of curricular units if credits are to be requested (MANDATORY, unless the course of origin is taught at the University of Coimbra under the Bologna Process - after 2007/2008);
- 3 - 1st Letter of Recommendation (MANDATORY);
- 4 - 2nd Letter of Recommendation (MANDATORY);
- 5 - Certificate of Bachelor's degree with final course classification (diploma). If credits are to be requested, a certificate indicating all curricular units completed and classification obtained on each of the curricular units is required (MANDATORY, except if the primary course is a course taught at the University of Coimbra);
- 6 - Certificate of Master's degree with final classification (diploma). If credits are to be requested, a certificate indicating all curricular units completed and classification obtained on each of the curricular units is required (MANDATORY, except if the primary course is a course taught at the University of Coimbra);
- 7 - Official document, issued by the institution awarding the degree, with certified grade (weighted average), (MANDATORY only for foreign candidates);
- 8 - Form (CV with indication of the academic background, participation in research projects, congresses and publications). This form should be downloaded, completed, scanned and then attached to the application (MANDATORY);
- 9 - Copy of Identification Document (MANDATORY only for foreign applicants).

NOTE: Admitted candidates who register and enroll in the course are required to present the original documents until the 31st of December in order to complete their individual student file.

The documents mentioned above must be certified by the local Portuguese consulate and / or legalized by the Apostille system under the Convention on Abolishing the Requirement of Legalization for Foreign Public Documents (better known as the Hague Convention), signed at The Hague, October 5, 1961, with the exception of documents issued by European Union Member-States. However, in case of doubt about the documentation presented, the aforementioned certification or submission of additional documentation may be requested to any applicant.

If the above-mentioned documents are in a foreign language other than Spanish, French or English, a translation must be presented. Translations must be duly certified by the competent authorities.
