**Bachelor's Degree in Geography**

**1. Number of places:**

1st call: 5 places

**2. Minimum number of students for course opening:** Not applicable.

**3. Application deadlines:**

1st call: 3rd June to 16th August 2019

**4. Admission requirements:**

Applicants through this regime must be:

1. Holders of a bachelor's, master's or doctor's degree;
2. Holders of the extinct courses of the Primary Magisterium, of Childhood Educators and of General Nursing that simultaneously hold a secondary education course, a complementary course of secondary education or a certificate of the 10th / 11th grade of schooling;
3. Not covered by the international student's statute regulated by Decree-Law no. 36/2014, of March 10, amended and republished by Decree-Law no. 62/2018, of August 6.
4. Prerequisite: Group D - Adequate vision according to the course requirements.

Note: Applicants of Portuguese nationality, with a higher academic degree obtained abroad, can apply as long as they hold degree equivalence or recognition of qualifications.

**5. Selection criteria:**

- Final classification, after application of the selection criteria (Weighting 10/10):

- a) Classification of the higher degree course, the course of the primary teaching profession, the course of the kindergarten teacher or the general nursing course, in descending order;
- b) Degree and diploma, priority being given successively to holders of a secondary course, of a higher education course without degree, of the previous course of bachelor (before the Bologna Process) and of the present course of bachelor.

If the classification referred to in point a) is included in the certificate with a decimal part, the certificate must be rounded off to the units, being a unit a fraction no lower than 5 decimals.

### **6. Required documentation:**

1. Workload and programmes of curricular units if credits are to be requested (MANDATORY, unless the course of origin is taught at the University of Coimbra under the Bologna Process - after 2007/2008);
2. Motivation letter (MANDATORY);
3. Transcript detailing subjects studied (ECTS or hours) and grade per subject is required (MANDATORY, except in degrees obtained at the University of Coimbra);
4. Diploma (higher education course) with overall grade (MANDATORY, except in degrees obtained at the University of Coimbra);
5. Curriculum vitae, EuroPass format (<http://europass.cedefop.europa.eu/>) (MANDATORY);
6. Copy of identification document.

NOTE: Admitted applicants who register and enroll in the course are required to present the original documents until the 31st of December in order to complete their individual student file.

The documents mentioned above must be certified by the local Portuguese consulate and/or legalized by the Apostille system under the Convention on Abolishing the Requirement of Legalization for Foreign Public Documents (better known as the Hague Convention), signed at The Hague, October 5, 1961, with the exception of documents issued by countries of the European Union. However, in case of doubt about the documentation presented, the aforementioned certification or submission of additional documentation may be requested to any applicant. If the abovementioned documents are in a foreign language other than Spanish, French or English, a translation is required. Translations must be duly certified by the competent authorities.

### **7. Tuition fee:**

- Portuguese students or equivalent: 871.52 EUR (annual fee).
