**2. Minimum number of students for course opening: 10**

**3. Application deadlines:**

2nd call: 1st April to 15th July 2019

3rd call: 19th August to 6th September 2019

Extra call: 14th to 31st October 2019

**4. Admission requirements:**

Master's applicants must hold:

- a) a Bachelor's degree in Law or equivalent;
  - b) a College degree awarded by a higher education institution from a foreign country signatory of the Bologna process, following completion of a first cycle programme in Law organized in accordance with the Bologna provisions;
  - c) a College degree in Law from a foreign institution, provided such degree is acceptable to the Coimbra Faculty of Law;
  - d) in duly justified cases, holders of an academic, scientific or professional curriculum acceptable to the Coimbra Faculty of Law;
  - e) a Law Degree must have a minimum classification of 13 points on the scale of 0-20;
  - f) a higher academic degree in Law obtained in Brazil must have a minimum classification of 8 points or higher (without rounding off), in the Brazilian scale of 0 to 10 points (note certified in an official document issued by the Institution that awarded the degree (Overall weighting coefficient, weighted average), submitted on the application page).
2. The recognition referred to in sub-paragraphs b) to d) of paragraph 1 merely provides access to the study cycle leading to the degree of master and does not confer on its holder the equivalence to the degree of bachelor or the recognition of that degree.

**5. Selection criteria:**

- Classification of bachelor's degree or other degrees obtained (10/10 Weighting).

**NOTES:**

- a) Regarding access under point 1 (d) of the conditions of admission, the Scientific Council shall assesses the curriculum according to the following terms, assigning a classification on a scale of 0 to 20 points:

1. Academic curriculum, considering the classification of the course (s) held and their relevance to

the scientific field of the study cycle (50%);

2. Scientific curriculum, considering the participation in congresses, seminars, research projects, number and scientific quality of publications (monographs, book chapters, articles in periodicals), prizes and similar elements, as long as they are activities in the scientific field of the study cycle (20%);

3. Professional curriculum, considering the duration and nature of the professional functions performed in the scientific field of the study cycle (30%);

b) Applicants who are admitted under point 1 of the conditions of admission must obtain a CV classification, calculated in accordance with point a), that is equal to or higher than 13 points.

**6. Required documentation:**

– Motivation letter, explaining the reasons that lead the applicant to apply, if relevant according to the criteria established by the organic unit of the desired course (MANDATORY);

- Workload and programmes of curricular units if credits are to be requested (MANDATORY, unless the course of origin is taught at the University of Coimbra under the Bologna Process - after 2007/2008);

- Certificate of Bachelor's degree with final classification (diploma). If credits are to be requested, a certificate indicating all curricular units completed and classification obtained on each of the curricular units is required (MANDATORY, except if the primary course is a course taught at the University of Coimbra);

- Curriculum Vitae (Europass format); (MANDATORY);

- Official document, issued by the institution awarding the degree, with certified grade (weighted average), (MANDATORY only for foreign candidates);

- Copy of Identification Document (MANDATORY only for foreign applicants).

**NOTE:** Admitted candidates who register and enroll in the course are required to present the original documents until the 31st of December in order to complete their individual student file.

The documents mentioned above must be certified by the local Portuguese consulate and / or legalized by the Apostille system under the Convention on Abolishing the Requirement of Legalization for Foreign Public Documents (better known as the Hague Convention), signed at The Hague, October 5, 1961, with the exception of documents issued by European Union Member-States. However, in case of doubt about the documentation presented, the aforementioned certification or submission of additional documentation may be requested to any applicant.

If the above-mentioned documents are in a foreign language other than Spanish, French or English, a translation must be presented. Translations must be duly certified by the competent authorities.

**7. Tuition fee:**

- Portuguese students or equivalent: 1,200 EUR (annual fee);
- International student: 7,000 EUR (annual fee).

**8. Part-time registration:** Allowed.

**9. Assessment committee:**

**10. Other information:**

- Application is subject to the payment of a fee in the amount of 50.00 €, non-refundable, including in cases of invalidation of application, non-placement or when the study cycle does not open due to the lack of the minimum number of enrollees.
- Registration and enrollment of International Students is only confirmed after a single payment corresponding to 30% of the total tuition fee (payment of 3 months of tuition), plus the application fee.
