3rd call: 19th August to 6th September 2019

### **4. Admission requirements:**

Holders of the Bachelor's degree in Sociology, in course of 4 or 5 years (pre-Bologna).

Pursuant to the Rectoral Order No. 137/2011.

### **5. Selection criteria:**

- Academic Curriculum: Pre-Bologna Degree in Sociology (4/10 Weighting);
- Professional Curriculum: Connection between the scientific field of the programme and the professional curriculum of the applicant (4/10 Weighting);
- Motivation (including, if necessary, an interview) Applicant's Profile (indicating the area or theme that the applicant intends to develop its master's project on) (2/10 Weighting).

**NOTE:** Assessed applications that have a grade lower than 9.5 in one of the evaluation criteria will

## **6. Required documentation:**

- Motivation letter, explaining the reasons that lead the applicant to apply, in case that is relevant to the criteria established by the Faculty they are applying to (MANDATORY);
- Course outlines and hourly course loads of previous courses, in case of equivalence credits request (MANDATORY, except in degrees awarded by a foreign institution according to the principles of the Bologna Process by a State compliant with this process / awarded by the University of Coimbra);
- Transcript detailing subjects studied (ECTS or hours) and grade per subject is required (MANDATORY, except in degrees obtained at the University of Coimbra);
- Certificate of other post-graduate courses completed, if any, including workload and programmes;
- Diploma (bachelor's degree or equivalent) with overall grade (MANDATORY, except in degrees obtained at the University of Coimbra);
- Curriculum vitae, EuroPass format (<http://europass.cedefop.europa.eu/>) (MANDATORY);
- Copy of identification document (MANDATORY for international applicants only).

**NOTE:** Admitted applicants who register and enroll in the course are required to present the original documents until the 31st of December in order to complete their individual student file.

The documents mentioned above must be certified by the local Portuguese consulate and / or legalized by the Apostille system under the Convention on Abolishing the Requirement of Legalization for Foreign Public Documents (better known as the Hague Convention), signed at The Hague, October 5, 1961, with the exception of documents issued by countries of the European Union. However, in case of doubt about the documentation presented, the aforementioned certification or submission of additional documentation may be requested to any applicant. If the abovementioned documents are in a foreign language other than Spanish, French or English, a translation is required. Translations must be duly certified by the competent authorities.

## **7. Tuition fee:**

- National Student or equivalent: 1,063,4 EUR (Fee amount subject to amendment by the General Council;
- International student: 7,000 EUR (annual fee).
