#### **3. Application deadlines:**

2nd call: 1st April to 15th July 2019 3rd call: 19th August to 6th September 2019

#### 4. Admission requirements:

1. Hold a Pre-Bologna degree in Dentistry. Pursuant to the Rectoral Order no.137 / 2011.

#### 5. Selection criteria:

- Final Average of Bachelor's Degree in Dentistry (1/3 Weighting);

- Having obtained the degree of bachelor in Dentistry at the University of Coimbra, (2/3 Weighting).

**Note**: As a tie-breaker, the year of conclusion of the degree will be used, being the degrees concluded for the longest time the most valuable.

#### 6. Required documentation:

- Motivation letter, explaining the reasons that lead the applicant to apply, in case that is relevant to

the criteria established by the Faculty they are applying to (MANDATORY);

- Course outlines and hourly course loads of previous courses, in case of equivalence credits request (MANDATORY, except in degrees awarded by a foreign institution according to the principles of the Bologna Process by a State compliant with this process / awarded by the University of Coimbra);

- Diploma (bachelor's degree or equivalent) with overall grade (MANDATORY, except in degrees obtained at the University of Coimbra). In caso of equivance of credits, you must include the certificate proving the approval in the curricular units carried out, with their respective classifications (school history). For holders of a degree obtained abroad, a document proving the recognition, equivalence or registration of degree in accordance with the applicable legislation is mandatory) (REQUIRED except for students and alumni of the Faculty of Medicine of the University of Coimbra);

- Copy of identification document (MANDATORY for international applicants only).

**NOTE**: Admitted applicants who register and enroll in the courseare required to present the original documents until the 31st of December in order to complete their individual student file.

The documents mentioned above must be certified by the local Portuguese consulate and / or legalized by the Apostille system under the Convention on Abolishing the Requirement of Legalization for Foreign Public Documents (better known as the Hague Convention), signed at The Hague, October 5, 1961, with the exception of documents issued by countries of the European Union. However, in case of doubt about the documentation presented, the aforementioned certification or submission of additional documentation may be requested to any applicant. If the abovementioned documents are in a foreign language other than Spanish, French or English, a translation is required. Translations must be duly certified by the competent authorities.

#### 7. Tuition fee:

- Portuguese students or equivalent: 871,52 EUR (annual fee);
- International student: 7,000 EUR (annual fee).
