3. Teachers teaching in the 3rd cycle of basic and secondary education - 15 points;

4. Teachers teaching in the 2nd cycle of basic education - 12 points;

In the event of a tie, an interview will be conducted in accordance with Article 8 (3) of the RAUC.

6. Required documentation:

- Motivation Letter (MANDATORY);

- Certificate of Degree with final grade (diploma) (MANDATORY, except for UC students and former students);

- Curriculum Vitae (MANDATORY);

- Copy of identification document (MANDATORY only for foreign applicants).

NOTE: Admitted applicants who register and enroll in the course are required to present the original documents until the 31st of December in order to complete their individual student file.

The documents mentioned above must be certified by the local Portuguese consulate and / or legalized by the Apostille system under the Convention on Abolishing the Requirement of Legalization for Foreign Public Documents (better known as the Hague Convention), signed at The Hague, October 5, 1961, with the exception of documents issued by European Union Member-States. However, in case of doubt about the documentation presented, the aforementioned certification or submission of additional documentation may be requested to any applicant. If the above-mentioned documents are in a foreign language other than Spanish, French or English, a translation must be presented. Translations must be duly certified by the competent authorities.
