1st cycle Bachelor's Degree in Social Work

1. Number of places: 1st call: 2 places

NOTE: The approval of the number of places depends on the guiding order regarding the establishment of places, for the academic year 2020/2021, which will be published by the Ministry of Science, Technology and Higher Education (MCTES) and which may, consequently, imply changes.

2. Minimum number of students for course opening: Não tem.

3. Application deadlines:

1st call: 1st June to 14th August 2020

4. Admission requirements:

Applicants through this regime are:

- Applicants with approval in the specially adapted exam to assess the capacity to attend higher education for students over 23, valid for the intended course.

- Applicants not covered by the international student's statute regulated by Decree-Law no. 36/2014 of 10 March, amended and republished by Decree-Law no. 62/2018, of 6 August.

5. Selection criteria:

- 1. Classification of the specially adapted exam to assess the capacity to attend higher education for students over 23, (4/5 Weighting);

- 2. In case of tie, priority will be given to applicants that have obtained exam approval first, (1/5 Weighting).

6. Required documentation:

- Identification document; (MANDATORY);

- Motivation Letter; (MANDATORY);

- Transcript detailing subjects studied (ECTS or hours) and grade per subject (MANDATORY, except in degrees obtained at the University of Coimbra);

- Workload and programmes of curricular units if credits are to be requested (MANDATORY, except in degrees awarded by the University of Coimbra under the Bologna Process – after 2007/2008).

NOTE: The submission of the authenticated original documents is mandatory to the applicants admitted who enrol and register and must be done until the 31st of December of the year of entry in order to complete their personal file.
