**Bachelor's Degree in Bioanalytical Sciences**

### **1. Number of places:**

2nd Call:

1st year: 3 places

Remaining years: 3 places

**NOTE:** The approval of the number of places depends on the guiding order regarding the establishment of places, for the academic year 2020/2021, which will be published by the Ministry of Science, Technology and Higher Education (MCTES) and which may, consequently, imply changes.

**2. Minimum number of students for course opening:** Not applicable.

### **3. Application deadlines:**

2nd call: 1st June to 14th August 2020

### **4. Admission requirements:**

1 - Students that request institution / course transfer must meet the following conditions:

a) To have been enrolled and registered in another institution / course, not having completed that course;

b) To have taken, in any previous school year, the national secondary education exams established for the course of application for the 2020/2021 academic year under the national higher education call ((02) Biology and Geology + (07) Physics and Chemistry);

c) To have obtained in these exams the minimum classification required by the University of Coimbra, in the academic year 2020/2021, under the general access regime (Entry exams: 95 points)

2 - The institution / course transfer applies equally to students who have been enrolled and registered in a foreign higher education institution in a course defined as a higher education course by the legislation of the country of the higher education institution, and who have not completed it.

3 - For students who hold non-Portuguese courses legally equivalent to Portuguese secondary education, the condition established by paragraph 1 may be fulfilled through the application of article 20-A of Decree-Law No. 296-A / 98, of September 25, in its updated form.

4 - For students who have enrolled in higher education through specially adapted tests to students over 23 years of age, the condition of admission laid down in paragraph 1 (b) and (c) may be replaced by the exams established for the course of application, for the 2020/2021 academic year, within the scope of the National Higher Education Call, as long as authorized by the Scientific Committee of the Faculty of Pharmacy the University of Coimbra. In order to submit the authorization request applicants must:

- file a request to the President of the Scientific Committee of the Faculty of Pharmacy before the end of the application deadline explaining the reasons for the request for [gbdirector@ff.uc.pt](mailto:gbdirector@ff.uc.pt) (preferably manually signed);

5 - For international students, the condition established by paragraph 1 (b) and (c) may be replaced by the exams established for the course of application, for the 2020/2021 academic year, within the scope of the National Higher Education Call.

6- The exams referred to in paragraph 1 (b) and 3 may have been taken in any school year.

7 - The transfer to an institution / course for which, according to the national higher education call, specific prerequisites or vocational skills are required, is conditioned to meeting these prerequisites.

Prerequisite: Group B - Interpersonal communication.

Documentation required: Medical statement, according to Annex IV of Deliberation No. 146-A/2016, proving that the applicant meets the prerequisite required at the time of enrollment and registration, without which enrolment and registration is not possible.

## 5. Selection criteria:

a) Average of classifications of the national access competition exams set for access to the desired degree/institution, for the year 2020/2021, under the general access regime or the average of

classifications of the exams used in the cases mentioned under 3, 4 and 5 of point 4 of this notice, (90/100 Weighting);

b) Motivation for the new academic course, considering the vocational aptitude shown by the consonance between the training goals and the goals of the degree to which the applicant aspires to. The motivation letter is the deciding factor in the cases when two or more applicants are competing for the last place available, (10/100 Weighting).

**6. Required documentation:**

- Declaration on honour (download), signed by the applicant, stating that he/she has not the Portuguese nationality, nor falls under any of the conditions that prevent him/her from applying to this competition, and that he/she has the necessary degree programme pre-requisites (when applicable). Self-declaration should be manually signed as identity document;
- Document that proves that the applicant sat for the exams and obtained the minimum grades required in the national access call exams/specific exams set for the degree to which he/she is applying (known as “Ficha ENES”) or the document that replaces it, in accordance with 3, 4 and 5 of number 4 of the present notice of opening; (MANDATORY);
- Document that proves that the candidate stills hold the right to enroll at University in the academic year to which he/she is applying, in the case of a candidate that was enrolled, in the previous academic year, in a Portuguese higher institution other than the University of Coimbra; (MANDATORY, except for students of the UC and candidates from foreign universities);
- Document that proves that the candidate was/is enrolled in a higher education institution and did not complete the degree at the basis of this application; (MANDATORY, except for students and ex-students of the UC);
- Identification document (MANDATORY only for foreign applicants);
- Motivation Letter; (MANDATORY);
- Transcript detailing subjects studied (ECTS or hours) and grade per subject (MANDATORY, except in degrees obtained at the University of Coimbra);
- Workload and programmes of curricular units if credits are to be requested (MANDATORY, except in degrees awarded by the University of Coimbra under the Bologna Process – after 2007/2008).

**NOTE:** If the documents mentioned above are written in a foreign language other than Spanish, French, and English, it is mandatory to present a translation to Portuguese undertaken by a translator recognised by the Portuguese diplomatic representation.

The submission of the authenticated original documents is mandatory to the applicants admitted who enrol and register and must be done until the 31st of December of the year of entry in order to

#### **7. Tuition fee:**

- Portuguese students or equivalent: 871,52 EUR (fee subject to change after approval of the 2020 state budget).
- International student: 7,000 EUR (annual fee).

#### **10. Other information:**

- Application is subject to the payment of a 50EUR fee, which is non-refundable, even in case of invalidation of application and of non-placement or when the study cycle does not open due to the lack of the minimum number of enrollees.
- Registration and enrollment of International Students is only confirmed after a single payment corresponding to 30% of the total tuition fee (payment of 3 months of tuition), plus the application fee.

- Applicants who do not have the documents attesting the required qualifications or other documents until the end of the deadline for applications may apply **conditionally**. If they do not submit the required documents until the new deadline provided, they can move their application into the following call without any additional charges. If they choose not to move their application within the mentioned deadline, their application will become “Not Admitted” in the final ranking list.
