Master's degree in Mathematics Teaching in the 3rd Cycle of Basic and Secondary Education

1. Number of places:

2nd call: 29 places

3rd call: 1 place + remaining places

2. Minimum number of students for course opening: Not applicable.

3. Application deadlines:

2nd call: 1st April to 15th July 2020

3rd call: 17th August to 15th September 2020

4. Admission requirements:

1. In accordance with D.L. 79/2014, applicants must meet all of the following conditions:

a) Hold a bachelor's degree or one of the qualifications referred to in points a) to c) of no. 1 of art. 17 of D.L. 65/2018;

b) Have completed at least 120 credits (ECTS) in the field of Mathematics in the bachelor's degree mentioned under a) or in other higher education degrees;

c) Have obtained approval in a written and oral exam aimed at verifying the command of the Portuguese language and the capacity for logical and critical argumentation.

2. Besides meeting the requirements of 1a) and 1c) but not 1b), have obtained 75% of the required

credits in teaching.

3. Besides meeting the requirements of 1b) and 1c) but not of 1a), hold a school, scientific or professional curriculum that is recognized as attesting to the capacity to carry out this cycle of studies as recognized by the Scientific Committee of FCTUC, having obtained a CV assessment of 9.5 out of 20 or higher.

NOTE: Access to Teaching Master's courses requires a Portuguese test. Please see the test dates at http://www.uc.pt/candidatos/escola./fluc/prova_portugues.

5. Selection criteria:

A. Quality of the academic and professional background (4/6 Weighting);

B. Commitment to the new course, (1/6 Weighting);

C. Duration of studies at the University of Coimbra (1/6 Weighting).

Regarding the access referred to in sub-paragraph d) of paragraph 1 of the conditions of admission:

The CV of applicants is rated on a scale of 0 to 20 in criteria i) to iv) and according to their respective weights:

i) Academic curriculum, considering the final classification of the degree(s) held (15%);

ii) Relevance of the degree(s) held for the scientific area of the study cycle (25%);

iii) Scientific curriculum, considering participation in congresses, seminars, research projects, number and scientific quality of publications (monographs, book chapters, articles in periodicals), prizes and similar awards, provided these activities are in the scientific area of the study cycle in question (25%);

iv) Professional curriculum, considering the duration and nature of the professional activities performed in the scientific area of the study cycle in question (35%).

NOTE: Assessed applications that have a grade lower than 9.5 in one of the evaluation criteria will automatically become non-approved.

6. Required documentation:

- Certificate of degree with final classification obtained (diploma). (MANDATORY, except if the origin course is a course taught at the University of Coimbra);

- Curriculum Vitae; (MANDATORY);

- Identification document (MANDATORY only for foreign applicants);

- Motivation Letter; (MANDATORY);

- Official declaration of course outlines and hourly course loads with classification of each course unit of courses previously taken (transcript), in case of equivalence credits request

(MANDATORY, except in degrees awarded by the University of Coimbra under the Bologna

Process – after 2007/2008);

- Official document, issued by the Institution awarding the degree, indicating the weighted average (MANDATORY only for foreign applicants that present a diploma that does not specify weighted average).

NOTE: If the documents mentioned above are written in a foreign language other than Spanish, French, and English, it is mandatory to present a translation to Portuguese undertaken by a translator recognised by the Portuguese diplomatic representation.

The submission of the authenticated original documents is mandatory to the applicants admitted who enrol and register and must be done until the 31st of December of the year of entry in order to complete their personal file.

7. Tuition fee:

- National student or equivalent: 871,52 EUR (fee subject to change after approval of the 2020 state budget);
- International student: 7,000 EUR (annual fee).

8. Part-time registration: Allowed.

9. Assessment committee:

- Joana Maria da Silva Teles Correia.

10. Other information:

- Application is subject to the payment of a 50EUR fee, which is non-refundable, even in case of invalidation of application and of non-placement or when the study cycle does not open due to the lack of the minimum number of enrollees.
- Registration and enrollment of International Students is only confirmed after a single payment corresponding to 30% of the total tuition fee (payment of 3 months of tuition), plus the application fee.
- Applications are submitted online at: <https://inforestudante.uc.pt/nonio/security/candidaturas.do>;
- Applicants who do not have the documents attesting the required qualifications or other documents until the end of the deadline for applications may apply **conditionally**. If they do not submit the required documents until the new deadline provided, they can move their application into the following call without any additional charges. If they choose not to move their application within the mentioned deadline, their application will become “Not Admitted” in the final ranking list.
- After the last phase of applications, and if there are still places available, applicants may submit
