\* Internal applicants: 10 places for applicants with Postgraduate studies in Economics and Management in Health Organizations from FEUC.

# 2 places that should be reserved for new FEUC bachelor graduates (graduation in the last 2 years).

### **2. Minimum number of students for course opening: 5**

### **3. Application deadlines:**

2nd call: 1st June to 16th July 2021

3rd call: 1st to 10th September 2021

### **4. Admission requirements:**

1. Applicants to the cycle of studies leading to this Master's degree must be:

- a) Holders of a bachelor's degree or legal equivalent, namely Bachelors's degrees taught in FEUC or equivalent, as well as holders of Bachelor's degrees in Medicine, Pharmacy, Nursing, Health Technologies or other Bachelor's degrees considered appropriate;
- b) Holders of a foreign higher academic degree awarded following a 1st cycle of studies organized

according to the principles of the Bologna Process by a State compliant with this Process, in the fields mentioned under a);

c) Holders of a higher academic degree obtained abroad that is recognized as meeting the objectives of the degree of bachelor in one of the areas mentioned under the previous points the competent Scientific Committee;

d) Holders of a school, scientific or professional curriculum recognized as attesting the capacity to pursue this cycle of studies by the Scientific Committee of the Organizational Unit.

2. The recognition referred to in sub-paragraphs b) to d) of paragraph 1 merely provides access to the study cycle leading to the degree of master and does not confer on its holder the equivalence to the degree of bachelor or the recognition of that degree.

### 5. Selection criteria:

1. Academic, professional and research Curriculum (10/10 Weighting).

1.1. Academic curriculum (60%)

Academic evolution of the candidates (2nd and 3rd cycles) and scientific area in which they obtained the degrees.

2.1. Professional and research curriculum (40%)

Existence of publications or participation in research projects and management and / or management functions that they may perform in their professional activity.

The situation of recent graduates is taken into account.

**NOTE:** Assessed applications that have a grade lower than 9.5 in one of the evaluation criteria will automatically become non-approved.

### 6. Required documentation:

- Certificate of Bachelor Degree with final grade average (diploma). If the certificate does not indicate the average of completion, a certificate proving approval in the curricular units carried out must be included, with respective classifications (school transcript) (MANDATORY, unless the course of origin is taught at the University of Coimbra);

- Certificate of other post-graduate courses completed, if any, including workload and programmes;

- Curriculum vitae, available at

- Identification document (MANDATORY only for foreign applicants);

- Motivation Letter; (MANDATORY);

- Official declaration of course outlines and hourly course loads with classification of each course unit of courses previously taken (transcript), in case of equivalence credits request;

(MANDATORY, except in degrees awarded by the University of Coimbra under the Bologna

Process – after 2007/2008);

- Official document, issued by the Institution awarding the degree, indicating the weighted average (MANDATORY only for foreign applicants that present a diploma that does not specify weighted average).

**NOTE:** If the documents mentioned above are written in a foreign language other than Spanish, French, and English, it is mandatory to present a translation to Portuguese undertaken by a translator recognised by the Portuguese diplomatic representation.

The submission of the authenticated original documents is mandatory to the applicants admitted who enrol and register and must be done until the 31st of December of the year of entry in order to complete their personal file.

**7. Tuition fee:**

- Portuguese students or equivalent: 1,650 EUR (annual fee);
- International student: 7,000 EUR (annual fee).

**8. Part-time registration:** Allowed.

**10. Other information:**

- Application is subject to the payment of a 50EUR fee, which is non-refundable, even in case of invalidation of application and of non-placement.
- Registration and enrollment of International Students is only confirmed after a single payment corresponding to 30% of the total tuition fee (payment of 3 months of tuition), plus the application fee.
- Applications are submitted online at: <https://inforestudante.uc.pt/nonio/security/candidaturas.do>.
- Applicants who do not have the documents attesting the required qualifications or other documents until the end of the deadline for applications may apply conditionally. If they do not submit the required documents until the new deadline provided, they can move their application into the following call without any additional charges. If they choose not to move their application within the mentioned deadline, their application will become “Not Admitted” in the final ranking list.
