### 1. Number of places:

#### 2. Minimum number of students for course opening: Not applicable

#### 3. Application deadlines:

-1st call: 1st to 30th April 2021

-2nd call: 1st June to 16th July 2021 -3rd call: 1st to 10th September 2021

#### 4. Admission requirements:

Applicants for admission to the Postgraduate Studies in Economics - Advanced Studies Diploma must be:

a) Holders of bachelor's degree, or legal equivalent, namely holders of degrees in Economics or Management by the Faculty of Economics of the University of Coimbra and the students of these degrees who lack 18 ECTS to obtain the degree. In the latter case, the award of the DEA diploma also implies the approval in those ECTS;

- b) Holders of a foreign higher academic degree awarded following a 1st cycle of studies organized according to the principles of the Bologna Process by a State compliant with this Process;
- c) Holders of foreign higher academic degree that is recognized as meeting the objectives of the bachelor's degree by the Scientific Committee of the Faculty of Economics;
- d) In duly justified cases, holders of a scientific and professional curriculum relevant for completing this cycle of studies as recognized the competent Scientific Committee.

#### 5. Selection criteria:

- 1.1 Academic curriculum: Undergraduate degree., (10/20 Weighting);
- 1.2 Academic curriculum: Other academic training., (2/20 Weighting);
- 1.3 Academic curriculum: Publications/Research., (1/20 Weighting);
- 2.1 Professional Curriculum: Extracurricular Activities, (1/20 Weighting);
- 2.2 Professional curriculum: Professional Experience assessment., (1/20 Weighting);
- 3.1 Motivation : Applicant's profile, (5/20 Weighting).

**Note**: Assessed applications that have a grade lower than 9.5 in one of the evaluation criteria will automatically become non-approved.

## 6. Required documentation:

- Certificate of Bachelor Degree with final grade average (diploma). If the certificate does not indicate the average of completion, a certificate proving approval in the curricular units carried out must be included, with respective classifications (school transcript) (MANDATORY, unless the course of origin is taught at the University of Coimbra);
- Certificate of other post-graduate courses completed, if any, including workload and programmes;
- Copy of identification document (MANDATORY only for foreign applicants);
- Curriculum Vitae; (MANDATORY);
- Motivation Letter; (MANDATORY);
- Official declaration of course outlines and hourly course loads with classification of each course unit of courses previously taken (transcript), in case of equivalence credits request (MANDATORY, except in degrees awarded by the University of Coimbra under the Bologna Process after 2007/2008);.

**Note**: If the documents mentioned above are written in a foreign language other than Spanish, French, and English, it is mandatory to present a translation to Portuguese undertaken by a translator recognised by the Portuguese diplomatic representation.

The submission of the authenticated original documents is mandatory to the applicants admitted who enrol and register and must be done until the 31st of December of the year of entry in order to complete their personal file. Further information

- In applications definitively considered valid, and after the evaluation period has started, it is not possible to add or replace the documents presented. To add new documentation, a new application must be submitted in the next phase, if any.
- After the last phase of applications, and if there are still places available, applicants may submit their application by means of a request, beyond the deadline, which will be duly appraised by the coordination of the Course /Organisational Unit.
