2. Minimum number of students for course opening: 10

3. Application deadlines:

1st call: 1st to 30th April 2021

2nd call: 1st June to 16th July 2021

3rd call: 1st to 10th September 2021

4. Admission requirements:

1. Applicants to the cycle of studies leading to this Master's degree must be:

- a) Holders of a bachelor's degree or legal equivalent;
- b) Holders of a foreign higher academic degree, conferred following a 1st cycle of studies organized according to the principles of the Bologna Process by a State compliant with this Process;
- c) Holders of a higher education academic degree obtained abroad that is recognized as meeting the objectives of the degree of bachelor in one of the areas mentioned under the previous points by the Scientific Committee of FCDEF;
- d) In duly justified cases, holders of a school, scientific and professional curriculum relevant for completing this cycle of studies as recognized by the Scientific Committee of FCDEF, having a CV assessment of 10 out of 20 or higher.

2. In a), b) and c) of paragraph 1, applications from graduates in related scientific areas are accepted, however, there will be a preferential criterion in relation to the field of Sports Sciences.
3. The recognition referred to in sub-paragraphs b) to d) of paragraph 1 merely provides access to the study cycle leading to the degree of master and does not confer on its holder the equivalence to the degree of bachelor or the recognition of that degree.

NOTE: The curricular units of specific training I and II, in the academic year 2021/22, will be offered in the modalities of Canoeing, Combat Sports, Football, Swimming and Skating.

3. Scientific production (Weighting 2/10);
 - 3.1. Congress participation or similar with presentation - 15 + 1 per presentation
 - 3.2. Participation in congress / seminar or similar without presentation, training courses without communication - 10
4. Experience in sports training (Weighting 1/10);
 - 4.1. The applicant is or was an athlete at national / international level - 14
 - 4.2. The applicant is or was a local or regional athlete - 10
 - 4.3. The applicant is or was a coach in competitions at national / international level - 20
 - 4.4. The applicant is or was a coach in competitions at local or regional level - 16

The application evaluator assesses the applicant's curriculum, rating it on the scale of 0 to 20 according to criteria i) to iv) and their respective weights:

- i) School curriculum, considering the final classification of the course (s) held (Weighting 10/100);
- ii) Relevance of the course (s) held for the scientific area of the study cycle of application (Weighting 10/100);
- iii) Scientific Curriculum, considering participation in congresses, seminars, research projects, number and scientific quality of publications (monographs, book chapters, articles in periodicals), prizes and similar awards, as long as they are activities in the scientific area of the study cycle in question (Weighting 70/100);
- iv) Professional curriculum, considering the duration and nature of the professional functions performed in the scientific area of the study cycle in question (Weighting 10/100).

6. Required documentation:

- Certificate of degree with final classification obtained (diploma). If the certificate does not indicate the average of completion, a certificate proving approval in the curricular units carried out must be included, with respective classifications (school transcript) (MANDATORY, except if the origin course is a course taught at the University of Coimbra);
- Form (CV with indication of the academic background, participation in research projects, congresses and publications). This form should be downloaded, completed, scanned and then attached to the application; (MANDATORY);
- Identification document (MANDATORY only for foreign applicants);
- Motivation Letter; (MANDATORY);
- Official declaration of course outlines and hourly course loads with classification of each course unit of courses previously taken (transcript), in case of equivalence credits request (MANDATORY, except in degrees awarded by the University of Coimbra under the Bologna Process – after 2007/2008);
- Official document, issued by the Institution awarding the degree, indicating the weighted average (MANDATORY only for foreign applicants that present a diploma that does not specify weighted average).

NOTE: If the documents mentioned above are written in a foreign language other than Spanish, French, and English, it is mandatory to present a translation to Portuguese undertaken by a translator recognised by the Portuguese diplomatic representation.

The submission of the authenticated original documents is mandatory to the applicants admitted who enrol and register and must be done until the 31st of December of the year of entry in order to complete their personal file.

10. Other information:

- Registration and enrollment of International Students is only confirmed after a single payment corresponding to 30% of the total tuition fee (payment of 3 months of tuition), plus the application fee.

- Applicants who do not have the documents attesting the required qualifications or other documents until the end of the deadline for applications may apply conditionally. If they do not submit the required documents until the new deadline provided, they can move their application into the following call without any additional charges. If they choose not to move their application within the mentioned deadline, their application will become "Not Admitted" in the final ranking list.
- In applications definitively considered valid, and after the evaluation period has started, it is not possible to add or replace the documents presented. To add new documentation, a new application must be submitted in the next phase, if any.
- After the last phase of applications, and if there are still places available, applicants may submit their application by means of a request, beyond the deadline, which will be duly appraised by the coordination of the Course /Organisational Unit.
