#### 4. Admission requirements:

Applicants through this regime are:

- Applicants with approval in the specially adapted exam to assess the capacity to attend higher education for students over 23, valid for the intended course.
- Applicants not covered by the international student's statute regulated by Decree-Law no. 36/2014 of 10 March, amended and republished by Decree-Law no. 62/2018, of 6 August.

- a) Classification of the specially adapted exam to assess the capacity to attend higher education for students over 23, (2/3 Weighting);
- b) Year in which the approval has been obtained, priority being given to applicants that have obtained it first, (1/3 Weighting).

NOTE: Assessed applications that have a grade lower than 9.5 in one of the evaluation criteria will automatically become non-approved.

## 6. Required documentation:

- 1- Identification document;
- 2- Motivation Letter; (MANDATORY);
- 3- Transcript detailing subjects studied (ECTS or hours) and grade per subject is required (MANDATORY, except in degrees obtained at the University of Coimbra);
- 4- Workload and programmes of curricular units if credits are to be requested (MANDATORY, except in degrees awarded by the University of Coimbra under the Bologna Process after 2007/2008).

NOTE: The submission of the authenticated original documents is mandatory to the applicants admitted who enrol and register and must be done until the 31st of December of the year of entry in order to complete their personal file.
