- Classification of the specially adapted exam to assess the capacity to attend higher education for students over 23, (10/10 Weighting).

6. Required documentation:

- 1- Identity Document;
- 2- Motivation Letter; (MANDATORY);
- 3- Transcript detailing subjects studied (ECTS or hours) and grade per subject (MANDATORY, except in degrees obtained at the University of Coimbra);
- 4- Workload and programmes of curricular units if credits are to be requested (MANDATORY, except in degrees awarded by the University of Coimbra under the Bologna Process after 2007/2008).

NOTE: The submission of the authenticated original documents is mandatory to the applicants admitted who enrol and register and must be done until the 31st of December of the year of entry in order to complete their personal file.
