1. Number of places:

1st call: 10 places

2nd call: 9 places

3rd call: 1 place + remaining places

2. Minimum number of students for course opening: Not applicable.

3. Application deadlines:

1st call: 1st to 31st March 2022

2nd call: 1st June to 15th July 2022

3rd call: 1st to 13th September 2022

4. Admission requirements:

1. Applicants to the cycle of studies leading to this Master's degree must be:

a) Holders of a Bachelor degree in Biology (or related areas) or legal equivalent;

b) Holders of a foreign higher academic degree in Biology (or related areas) conferred following a 1st cycle of studies, organized according to the principles of the Bologna Process by a State adhering to this Process;

c) Holders of a foreign higher academic degree in Biology (or related areas) that is recognized as satisfying the objectives of the Bachelor degree by the CC responsible for this cycle of Master studies;

d) In duly justified cases, holders of an academic, scientific and professional curriculum relevant for

completing this cycle of studies as recognized by the Scientific Committee of FCTUC, having a CV assessment of 10 out of 20 or higher.

e) Have English proficiency certified internationally by the IELTS system (minimum of 6.5) or equivalent (TOEFL iBT 92, pBT 580). This criterion does not apply to English native speaking countries.

2. The recognition referred to in sub-paragraphs b) to d) of paragraph 1 merely provides access to the study cycle leading to the degree of master and does not confer on its holder the equivalence to the degree of bachelor or the recognition of that degree.

5. Selection criteria:

- A. Quality of the academic and professional course, (4/6 Weighting);
- B. Interest in the new course, (1/6 Weighting);
- C. Quality of previously acquired experience, (1/6 Weighting);

Regarding the access referred to in sub-paragraph d) of paragraph 1 of the conditions of admission: The CV of applicants is rated on a scale of 0 to 20 in criteria i) to iv) and according to their respective weights:

- i) Academic curriculum, considering the final classification of the degree(s) held (50%);
- ii) Relevance of the degree(s) held for the scientific area of the study cycle (25%);
- iii) Scientific curriculum, considering participation in congresses, seminars, research projects, number and scientific quality of publications (monographs, book chapters, articles in periodicals), prizes and similar awards, provided these activities are in the scientific area of the study cycle in question (15%);
- iv) Professional curriculum, considering the duration and nature of the professional activities performed in the scientific area of the study cycle in question (10%).

NOTE: The assessed applications that have a grade lower than 9.5 in one of the evaluation criteria will automatically become non-approved.

6. Required documentation:

- Additional letter can be provided if needed, explaining particular issue(s) and/or missing document(s);
- Application form duly filled (downloaded from the IMAE website) (MANDATORY);
- Certificate of the required degree and a copy translated into English, (MANDATORY, except if the origin course is a course taught at the University of Coimbra);
- Certification of English proficiency (IELTS, TOEFL, Cambridge or other) (MANDATORY)

except for applicants from countries where English is a native language);

- Curriculum Vitae; (MANDATORY);
- Identity Card, Citizen Card or Passport (MANDATORY only for international applicants);
- Motivation Letter; (MANDATORY);
- Transcript of records and a copy translated into English, (MANDATORY, except if the origin course is a course taught at the University of Coimbra);
- Two letters of recommendation; (MANDATORY).

NOTE: If the documents mentioned above are written in a foreign language other than Spanish, French, and English, it is mandatory to present a translation to Portuguese undertaken by a translator recognised by the Portuguese diplomatic representation.

The submission of the authenticated original documents is mandatory to the applicants admitted who enrol and register and must be done until the 31st of December of the year of entry in order to complete their personal file.

- National Student or equivalent: 4,500 EUR (annual fee);
- International student: 9,000 EUR (annual fee).

10. Other information:

- Application is subject to the payment of a 50.00 € fee, which is non-refundable, even in case of invalidation of application and of non-placement.
- Registration and enrollment of International Students is only confirmed after a single payment corresponding to 30% of the total tuition fee (payment of 3 months of tuition), plus the application fee.

- Applicants who do not have the documents attesting the required qualifications or other documents until the end of the deadline for applications may apply conditionally. If they do not submit the required documents until the new deadline provided, they can move their application into

the following call without any additional charges. If they choose not to move their application within the mentioned deadline, their application will become "Not Admitted" in the final ranking list.

- In applications definitively considered valid, and after the evaluation period has started, it is not possible to add or replace the documents presented. To add new documentation, a new application must be submitted in the next phase, if any.
- After the last phase of applications, and if there are still places available, applicants may submit their application by means of a request, beyond the deadline, which will be duly appraised by the coordination of the Course /Organisational Unit.
