### **1. Number of places:**

1st call: 11 places

2nd call: 13 places

**2. Minimum number of students for course opening:** Not applicable.

### **3. Application deadlines:**

1st call: 1st to 31st March 2022

2nd call: 1st June to 15th July 2022

3rd call: 1st to 13th September 2022

Supplemental application call: 17th to 28th October 2022

### **4. Admission requirements:**

1 - Applications for the PhD in Electrical and Computer Engineering must be:

a) Holders of the master's degree or legal equivalent in Electrical Engineering, Electronic Engineering, Telecommunications Engineering, Computer Engineering, Physical Engineering, Biomedical Engineering or any other related engineering;

b) Holders of a bachelor's degree obtained for at least 2 years and with an average of not less than 16 values, in Electrical Engineering, Electronic Engineering, Engineering Telecommunications,

Informatics Engineering, Physical Engineering Biomedical Engineering or any other related engineering, holders of a especially relevant academic or scientific curriculum that is recognized as attesting to the capacity to carry out this cycle of studies;

c) In duly justified cases, holders of a school, scientific or professional curriculum relevant for pursuing this cycle of studies as recognized by the Scientific Committee of FCTUC. Applicants must obtain a curricular evaluation equal to or higher than 14 points.

2 - The recognition referred to in subparagraphs b) and c) of paragraph 1 only allows access to the cycle of studies leading to a PhD Degree and does not grant its holder the recognition or equivalence to a Bachelor's or Master's Degree.

### **5. Selection criteria:**

1. Cv Assessment, (10/10 Weighting);

Regarding the access referred to in sub-paragraph c) of paragraph 1 of the conditions of admission the application evaluator assesses the CV of applicants and rates it on a scale of 0 to 20 following the criteria i) to ii) and their respective weights:

i) School curriculum, considering the final classification of the course (s) taken by the applicant (60%);

ii) Relevance of the course (s) taken to the scientific area of the study cycle to which you they are applying; Scientific Curriculum, considering the participation of applicants in congresses, seminars, research projects, number and scientific quality of publications (monographs, book chapters, articles in periodicals), prizes and similar elements, as long as these activities are developed in the scientific area of the study cycle in question; Professional curriculum, considering the duration and nature of the professional activity in the scientific area of the study cycle in question (40%).

NOTE: Assessed applications that have a grade lower than 9.5 in one of the evaluation criteria will automatically become non-approved.

1 - 1st Letter of Recommendation; (MANDATORY);

2 - 2nd Letter of Recommendation; (MANDATORY);

3 - Certificate of Bachelor's degree with final course classification (diploma). If the certificate does not indicate the average of completion, a certificate proving approval in the curricular units carried out must be included, with respective classifications (school transcript); (MANDATORY, except if the primary course is a course taught at the University of Coimbra);

- 4 - Certificate of Master's degree with final classification (diploma). If the certificate does not indicate the average of completion, a certificate proving approval in the curricular units carried out must be included, with respective classifications (school transcript); (MANDATORY, except if the primary course is a course taught at the University of Coimbra);
- 5 - Curriculum vitae; (MANDATORY);
- 6 - Identity Document; (MANDATORY only for foreign applicants);
- 7 - Motivation Letter; (MANDATORY);
- 8 - Official declaration of course outlines and hourly course loads with classification of each course unit of courses previously taken (transcript), in case of equivalence credits request; (MANDATORY, except in degrees awarded by the University of Coimbra under the Bologna Process – after 2007/2008);
- 9 - Official document, issued by the institution conferring the degree, with certified grade (weighted average); (MANDATORY only for foreign candidates).

NOTE: If the documents mentioned above are written in a foreign language other than Spanish, French, and English, it is mandatory to present a translation to Portuguese undertaken by a translator recognised by the Portuguese diplomatic representation.

The submission of the authenticated original documents is mandatory to the applicants admitted who enrol and register and must be done until the 31st of December of the year of entry in order to complete their personal file.

- After the last phase of applications, and if there are still places available, applicants may submit their application by means of a request, beyond the deadline, which will be duly appraised by the coordination of the Course /Organisational Unit.
