2. Minimum number of students for course opening: 6

3. Application deadlines:

1st call: 1st to 31st March 2022

2nd call: 1st June to 15th July 2022

3rd call: 1st to 13th September 2022

4. Admission requirements:

1- Applicants for admission to the PhD programme in Portuguese Language Literature must be:

a) Holders of a master's degree, or legal equivalent;

b) Holders of a bachelor's degree, holders of a particularly relevant academic or scientific curriculum that is recognized as attesting the capacity to complete this cycle of studies by the Academic Board of the Faculty of Arts and Humanities;

c) Holders of a school, scientific or professional curriculum that is recognized as attesting the capacity to complete this cycle of studies by the Academic Board of the Faculty of Arts and Humanities. Applicants must obtain a curricular evaluation equal to or higher than 9.5 points.

2 - The recognition referred to in subparagraphs b) and c) of paragraph 1 only allows access to the cycle of studies leading to a PhD Degree and does not grant its holder the recognition or equivalence to a Bachelor's or Master's Degree.

5. Selection criteria:

- a) Classification obtained in the presented degrees (Weighting 4/10);
- b) Specific qualifications relevant to the scientific scope of the Course (Weighting 2/10);
- c) Scientific Curriculum (Weighting 2/10):
 - c1) curriculum not relevant - 10 points;
 - c2) between 1 and 3 publications or communications in scientific meetings or participation in research projects - 14 points;
 - c3) between 4 and 6 publications or communications in scientific meetings or participation in research projects - 16 points;
 - c4) 7 or more publications or communications in scientific meetings or participation in research projects - 18 points;
- d) Work experience (Weighting 2/10):
 - d1) no professional experience - 10 points;
 - d2) between 1 and 3 years of professional experience in the field of education or arts and culture - 14 points;
 - d3) between 4 and 7 years of professional experience in the teaching or arts and culture sector - 16 points;
 - d4) 8 or more years of professional experience in the field of education or arts and culture - 18 points;
 - d5) between 1 and 5 years of professional experience in another sector - 12 points.

NOTE: The application may include an interview if it is necessary to clarify any particular point regarding the documentation or information contained in the applicant's file.

Regarding the access referred to in sub-paragraph c) of paragraph 1 of the conditions of admission the application evaluator assesses the CV of applicants and rates it on a scale of 0 to 20 following the criteria i) to iv) and their respective weights:

- i) School curriculum, considering the final classification of the course (s) taken by the applicant, (25/100 Weighting);
- ii) Relevance of the course (s) taken to the scientific area of the study cycle to which you they are applying, (25/100 Weighting);
- iii) Scientific Curriculum, considering the participation of applicants in congresses, seminars, research projects, number and scientific quality of publications (monographs, book chapters, articles in periodicals), prizes and similar elements, as long as these activities are developed in the scientific area of the study cycle in question, (25/100 Weighting);
- iv) Professional curriculum, considering the duration and nature of the professional activity in the scientific area of the study cycle in question, (25/100 Weighting).

NOTE: Assessed applications that have a grade lower than 9.5 in one of the evaluation criteria will automatically become non-approved.

- 1 - 1st Letter of Recommendation; (MANDATORY);
- 2 - 2nd Letter of Recommendation; (MANDATORY);
- 3 - Certificate of Bachelor's degree with final course classification (diploma). If the certificate does not indicate the average of completion, a certificate proving approval in the curricular units carried out must be included, with respective classifications (school transcript); (MANDATORY, except if the primary course is a course taught at the University of Coimbra);
- 4 - Certificate of Master's degree with final classification (diploma). If the certificate does not indicate the average of completion, a certificate proving approval in the curricular units carried out must be included, with respective classifications (school transcript); (MANDATORY, except if the primary course is a course taught at the University of Coimbra);
- 5 - Curriculum vitae; (MANDATORY);

- 6 - Identity Document; (MANDATORY only for foreign applicants);
- 7 - Motivation Letter; (MANDATORY);
- 8 - Official declaration of course outlines and hourly course loads with classification of each course unit of courses previously taken (transcript), in case of equivalence credits request; (MANDATORY, except in degrees awarded by the University of Coimbra under the Bologna Process – after 2007/2008);
- 9 - Official document, issued by the institution conferring the degree, with certified grade (weighted average); (MANDATORY, only for foreign candidates).

NOTE: If the documents mentioned above are written in a foreign language other than Spanish, French, and English, it is mandatory to present a translation to Portuguese undertaken by a translator recognised by the Portuguese diplomatic representation.

The submission of the authenticated original documents is mandatory to the applicants admitted who enrol and register and must be done until the 31st of December of the year of entry in order to complete their personal file.

- Application is subject to the payment of a 50.00 € fee, which is non-refundable, even in case of invalidation of application and of non-placement.

- Applicants who do not have the documents attesting the required qualifications or other documents until the end of the deadline for applications may apply conditionally. If they do not submit the required documents until the new deadline provided, they can move their application into the following call without any additional charges. If they choose not to move their application within the mentioned deadline, their application will become "Not Admitted" in the final ranking list.
- In applications definitively considered valid, and after the evaluation period has started, it is not
