# 4. Admission requirements:

- 1. Hold a bachelor's, master's or doctor's degree;
- 2. Hold the extinct courses of the Primary Magisterium, of Childhood Educators and of General Nursing and also a secondary education course, a complementary course to the secondary education or the 10th / 11th grade of secondary school;
- 3. Holders of medical statement of aptitude to study Physical Education and Sports;

- 4. Holders of certificate of aptitude in the prerequisites Group C or H Functional, physical and sports aptitude (taken in the year of the application);
- 5. Are not covered by the international student's statute regulated by Decree-Law no. 36/2014, of March 10, amended and republished by Decree-Law no. 62/2018, of August 6.

**NOTE**: Applicants of Portuguese nationality or equivalent, with a higher academic degree obtained abroad, can apply as long as they hold a degree equivalence or recognition of qualifications.

# 5. Selection criteria:

A. Final classification of the higher education course held, rounded off to the whole number (7/10 Weighting);

- B. Degree and diploma, priority being successively given to the holders of (3/10 Weighting):
- a) Bachelor's degree (3-year pre-Bologna degree) (20 points);
- b) Bachelor's degree (18 values);
- c) Master's degree (16 points);
- d) Doctor's degree (14 points).

**NOTE**: Assessed applications that have a grade lower than 9.5 in one of the evaluation criteria will automatically become non-approved.

# 6. Required documentation:

- Certificate from higher education course completed with average classification obtained; (MANDATORY, except in degrees obtained at the University of Coimbra);
- Certificate of Prerequisites (taken in the year of application); (MANDATORY);
- Curriculum Vitae; (MANDATORY);
- Identification document;
- Medical statement attesting that the applicant is in appropriate physical condition to pursue this cycle of studies (issued less than 6 months prior to application); (MANDATORY);
- Motivation Letter; (MANDATORY);
- Transcript detailing subjects studied (ECTS or hours) and grade per subject (MANDATORY, except in degrees obtained at the University of Coimbra);
- Workload and programmes of curricular units if credits are to be requested (MANDATORY,

except in degrees awarded by the University of Coimbra under the Bologna Process – after 2007/2008).

**NOTE**: The submission of the authenticated original documents is mandatory to the applicants admitted who enrol and register and must be done until the 31st of December of the year of entry in order to complete their personal file.
