Prerequisite: Group B - Interpersonal communication.

Documentation required: Medical statement, according to Annex IV of Deliberation No. 146-A/2016, proving that the applicant meets the prerequisite required at the time of enrollment and registration, without which enrolment and registration is not possible.

**NOTE:** Applicants of Portuguese nationality or equivalent, with a higher academic degree obtained abroad, can apply as long as they hold a degree equivalence or recognition of qualifications.

### **6. Required documentation:**

- A copy of the syllabus of the course of origin, and transition plan, if, however during the course of this course has been appropriate to Bologna; MANDATORY unless it is a course taught at the University of Coimbra);
- Certificate from higher education course completed with average classification obtained; (MANDATORY, except in degrees obtained at the University of Coimbra);
- Curriculum Vitae; (MANDATORY);
- Identification document;
- Motivation Letter; (MANDATORY);
- Transcript detailing subjects studied (ECTS or hours) and grade per subject (MANDATORY, except in degrees obtained at the University of Coimbra);
- Workload and programmes of curricular units if credits are to be requested (MANDATORY, except in degrees awarded by the University of Coimbra under the Bologna Process – after 2007/2008). See additional information in the notice of opening.

**NOTE:** The submission of the authenticated original documents is mandatory to the applicants admitted who enrol and register and must be done until the 31st of December of the year of entry in order to complete their personal file.
