2. Minimum number of students for course opening: Not applicable

3. Application deadlines:

1st call: 3rd July to 18th August 2023

4. Admission requirements:

This regime accepts applicants that:

- 1. Hold a bachelor's, master's or doctor's degree;
- 2. Hold the extinct courses of the Primary Magisterium, of Childhood Educators and of General Nursing and also a secondary education course, a complementary course to the secondary education or the 10th / 11th grade of secondary school;
- 3. Are not covered by the international student's statute regulated by Decree-Law no. 36/2014, of March 10, amended and republished by Decree-Law no. 62/2018, of August 6.

NOTE: Applicants of Portuguese nationality or equivalent, with a higher academic degree obtained abroad, can apply as long as they hold a degree equivalence or recognition of qualifications.

5. Selection criteria:

- A Assessment of the applicant's educational and professional curriculum [8/10 Weighting]:
- a) Work experience (7/20);
- b) Management-related work experience (7/20);
- c) School CV (2/20);
- d) Additional training (4/20);
- B Assessment of the applicant's motivations (through written text) [2/10 Weighting]:
- a) Objectivity in explaining the reasons (6/20);
- b) Objectivity in describing skills (6/20);
- c) Size of the text on the motivations (2/20);
- d) Grammatical correction in the written expression of motivations (3/20);
- e) Text spelling correction (3/20).

NOTE: Assessed applications that have a grade lower than 9.5 in one of the evaluation criteria will automatically become non-approved.

6. Required documentation:

- 1- Certificate from higher education course completed with average classification obtained; (MANDATORY, except in degrees obtained at the University of Coimbra);
- 2- Curriculum Vitae; (MANDATORY);
- 3- Identity Document;
- 4- Motivation Letter; (MANDATORY);
- 5- Transcript detailing subjects studied (ECTS or hours) and grade per subject (MANDATORY, except in degrees obtained at the University of Coimbra);
- 6- Workload and programmes of curricular units if credits are to be requested (MANDATORY, except in degrees awarded by the University of Coimbra under the Bologna Process after 2007/2008).

NOTE: If the documents mentioned above are written in a foreign language other than Spanish, French, and English, it is mandatory to present a translation to Portuguese undertaken by a translator recognised by the Portuguese diplomatic representation.
