**4. Admission requirements:**

Applicants through this regime are:

- Applicants with approval in the specially adapted exam to assess the capacity to attend higher education for students over 23, valid for the intended course.
- Applicants not covered by the international student's statute regulated by Decree-Law no. 36/2014 of 10 March, amended and republished by Decree-Law no. 62/2018, of 6 August.
- Prerequisite: Group B - Interpersonal communication.

Documentation required: Medical statement, according to Annex IV of Deliberation No. 338/2023, proving that the applicant meets the prerequisite required at the time of enrollment and registration, without which enrolment and registration is not possible.9.

**5. Selection criteria:**

- a) Classification of the specially adapted exam to assess the capacity to attend higher education for students over 23, [2/3 Weighting];
- b) Year in which the approval has been obtained, priority being given to applicants that have obtained it first, [1/3 Weighting].

## **6. Required documentation:**

- 1- Identification document;
- 2- Motivation Letter; (MANDATORY);
- 3- Transcript detailing subjects studied (ECTS or hours) and grade per subject is required (MANDATORY, except in degrees obtained at the University of Coimbra);
- 4- Workload and programmes of curricular units if credits are to be requested (MANDATORY, except in degrees awarded by the University of Coimbra under the Bologna Process – after 2007/2008).

NOTE: If the documents mentioned above are written in a foreign language other than Spanish, French, and English, it is mandatory to present a translation to Portuguese undertaken by a translator recognised by the Portuguese diplomatic representation.
