#### 4. Admission requirements:

Applicants through this regime are:

- Applicants with approval in the specially adapted exam to assess the capacity to attend higher education for students over 23, valid for the intended course.
- Applicants not covered by the international student's statute regulated by Decree-Law no. 36/2014 of 10 March, amended and republished by Decree-Law no. 62/2018, of 6 August.

#### 5. Selection criteria:

- 1. Classification of the specially adapted exam to assess the capacity to attend higher education for students over 23, [4/5 Weighting];
- 2. In case of tie, priority will be given to applicants that have obtained exam approval first, [1/5 Weighting].

#### 6. Required documentation:

- 1- Identification document; (MANDATORY);
- 2- Motivation Letter; (MANDATORY);
- 3- Transcript detailing subjects studied (ECTS or hours) and grade per subject (MANDATORY, except in degrees obtained at the University of Coimbra);
- 4- Workload and programmes of curricular units if credits are to be requested (MANDATORY, except in degrees awarded by the University of Coimbra under the Bologna Process after 2007/2008).

NOTE: If the documents mentioned above are written in a foreign language other than Spanish, French, and English, it is mandatory to present a translation to Portuguese undertaken by a translator recognised by the Portuguese diplomatic representation.
