- 2nd call: 1place + remaining places

2. Minimum number of students for course opening: 20

3. Application deadlines:

- 1st call: 1st August to 10th September 2023

- 20th call: 19th to 27th September 2023

4. Admission requirements:

General population, namely elderly caregivers, with preference to professionals in healthcare.

The motivation letter and the CV should explain the training and/or experience as a caregiver and other relevant elements for the application to attend the course.

For the purposes of evaluation and seriation of applications, a curricular evaluation will be carried out.

5. Selection criteria:

- Clarity of skills you want to acquire expressed in the motivation letter, [5/20 Weighting];
- Experience in Elderly Care, [6/20 Weighting];
- Objectives of knowledge transfer to practice expressed in the motivation letter, [5/20 Weighting];
- Training held in the area of health, [4/20 Weighting].

- Declaration on honour of the veracity of documents and data submitted to the UC (document available in Inforestudante, in the application area).; (MANDATORY);
- Motivation Letter in Portuguese; (MANDATORY).
