1. Number of places:

1st call: 3 places

2nd call: 21 places

3rd call: 1 place + remaining places

Extraordinary call: remaining places

2. Minimum number of students for course opening: 15

3. Application deadlines:

1st call: 1st to 31st March 2023

2nd call: 1st June to 14th July 2023

3rd call: 1st to 13th September 2023

Extraordinary call: 9th to 13th October 2023

4. Admission requirements:

1. Applicants to the master's degree should be:

- a) holders of a Bachelor's degree or legal equivalent in Pharmaceutical Sciences or in the area of the Health Sciences whose personal curriculum reveals an adequate basic scientific preparation, namely in the field of Pharmaceutical Chemistry;
- b) holders of a foreign higher academic degree, that was awarded after accomplishing a 1st cycle of studies, which should be structured according to the principles of the Bologna Process in an adhering country to this Process, in the areas referred to in point a);
- c) holders of a foreign higher academic degree that is recognized to meet the objectives of the

Bachelor's degree by the legal competent Scientific Council of the Faculty of Pharmacy.

d) Holders of an academic, scientific or professional CV recognized as adequate for pursuing this cycle of studies by the Scientific Committee of the Faculty of Pharmacy of the University of Coimbra, in which applicants must obtain an evaluation of 14 points or higher.

2. The recognition referred to in sub-paragraphs b) to d) only results in access to the study cycle leading to the master's degree and does not confer on the holder the equivalence to the bachelor's degree or the recognition of that degree.

5. Selection criteria:

1) Adequacy of the academic, scientific and professional curriculum. (Weighting 2/3);

1.1.) Adequacy of 1st Cycle course to the profile of the Master in Industrial Pharmaceutical Chemistry of the Faculty of Pharmacy of the University of Coimbra;

1.1.1) recognition of academic merit in the 1st cycle course;

1.1.2) recognition of the adequacy of 1st cycle course to the requirements and profiles of the Master in Industrial Pharmaceutical Chemistry;

1.2) recognition of scientific merit, namely publications, participation in projects and other scientific activities.

2) Classification of access qualification (Weighting 1/3).

Regarding the access referred to in sub-paragraph d) of paragraph 1 of the conditions of admission: The CV of applicants is rated on a scale of 0 to 20 in criteria i) to iv) and according to their respective weights:

i) Academic curriculum, considering the final classification of the degree(s) held (22%);

ii) Relevance of the degree(s) held for the scientific area of the study cycle (30%);

iii) Scientific curriculum, considering participation in congresses, seminars, research projects, number and scientific quality of publications (monographs, book chapters, articles in periodicals), prizes and similar awards, provided these activities are in the scientific area of the study cycle in question (30%);

iv) Professional curriculum, considering the duration and nature of the professional activities performed in the scientific area of the study cycle in question (20%).

NOTE: Assessed applications that have a grade lower than 9.5 in one of the evaluation criteria will automatically become non-approved.

6. Required documentation:

- Certificate of Bachelor Degree with final grade average (diploma). If the certificate does not

indicate the average of completion, a certificate proving approval in the curricular units carried out must be included, with respective classifications (school transcript) (MANDATORY, unless the course of origin is taught at the University of Coimbra);

- Curriculum Vitae; (MANDATORY);
- Identification document (MANDATORY only for foreign applicants);
- Motivation Letter; (MANDATORY);
- Official declaration of course outlines and hourly course loads with classification of each course unit of courses previously taken (transcript), in case of equivalence credits request (MANDATORY, except in degrees awarded by the University of Coimbra under the Bologna Process – after 2007/2008);
- Official document, issued by the Institution awarding the degree, indicating the weighted average (MANDATORY only for foreign applicants that present a diploma that does not specify weighted average).

NOTE: If the documents mentioned above are written in a foreign language other than Spanish, French, and English, it is mandatory to present a translation to Portuguese undertaken by a translator recognised by the Portuguese diplomatic representation.

The submission of the authenticated original documents is mandatory to the applicants admitted who enrol and register and must be done as soon as possible in order to complete their personal file. Further information at: <https://www.uc.pt/en/academicos/Inscricoes/PIAs>.

7. Tuition fee:

- National Student or equivalent: 1,250 EUR (annual fee);
- International student: 7,000 EUR (annual fee).
