2nd cycle Master in Social Dynamics, Natural and Technological Risks

1. Number of places:

1st call: 6 places 2nd call: 11 places 3rd call: 1 place + remaining places

2. Minimum number of students for course opening: 5

3. Application deadlines:

1st call: 1st March to 1st April 2024 2nd call: 3rd June to 15th July 2024 3rd call: 2nd to 13th September 2024

4. Admission requirements:

1. Applicants to this 2nd cycle course must be:

a) Holders of a bachelor's degree or its equivalent;

b) Holders of a higher education degree awarded by a foreign institution after a 1st cycle of studies structured according to the principles of the Bologna Process by a participating country;

c) Holders of a higher education degree by a foreign institution recognized as fulfilling the

objectives of a bachelor's degree by the Scientific Committee responsible for the study cycle;

d) Holders of an academic, scientific or professional curriculum vitae that is recognized as attesting the capacity to successful complete this cycle of studies as recognized by the Scientific Committee responsible by the study cycle, having a CV assessment of 12 out of 20 or higher.

2. The recognition referred to in sub-paragraphs b) to d) of paragraph 1 only provides access to the



study cycle leading to the degree of master and does not confer the equivalence to the degree of bachelor or the recognition of that degree.

5. Selection criteria:

1.1 Academic curriculum: Undergraduate degree, (3/10 Weighting);

1.2 Academic Curriculum: Other academic training, (2/10 Weighting);

1.3 Academic Curriculum: Publications / Research, (1/10 Weighting);

2.1. Professional CV: Professional merit assessment, (3/10 Weighting);

3.1 Motivation (including an interview, if necessary): Candidate's profile, (1/10 Weighting);

Regarding the access referred to in sub-paragraph d) of paragraph 1 of the conditions of admission: The CV of applicants is rated on a scale of 0 to 20 in criteria i) to iv) and according to their respective weights:

i) Academic curriculum, considering the final classification of the degree(s) held, (20/100 Weighting);

ii) Relevance of the degree(s) held for the scientific area of the study cycle, (20/100 Weighting);
iii) Scientific curriculum, considering participation in congresses, seminars, research projects, number and scientific quality of publications (monographs, book chapters, articles in periodicals), prizes and similar awards, provided these activities are in the scientific area of the study cycle in question, (20/100 Weighting);

iv) Professional curriculum, considering the duration and nature of the professional activities performed in the scientific area of the study cycle in question, (40/100 Weighting).

NOTE: Assessed applications that have a grade lower than 9.5 in one of the evaluation criteria will automatically become non-approved.

6. Required documentation:

- Certificate from other post-graduate courses completed, if any, including time and program;

- Certificate of Bachelor's degree with final course classification (diploma). A certificate proving approval in the curricular units carried out must be included, with respective classifications (school transcript). (MANDATORY, except if the primary course is a course taught at the University of Coimbra);

- Curriculum Vitae; (MANDATORY);

- Identification document (MANDATORY only for foreign applicants);

- Motivation Letter; (MANDATORY);

Official declaration of course outlines and hourly course loads with classification of each course unit of courses previously taken (transcript), in case of equivalence credits request (MANDATORY, except in degrees awarded by the University of Coimbra under the Bologna Process – after 2007/2008);

- Official document certifying qualifications, issued by the institution awarding the degree, indicating the weighted average and the grading scale. (MANDATORY only for holders of a degree obtained abroad that does not contain the average).

NOTE: If the documents mentioned above are written in a foreign language other than Spanish, French, and English, it is mandatory to present a translation to Portuguese undertaken by a translator recognised by the Portuguese diplomatic representation.

The submission of the authenticated original documents is mandatory to the applicants admitted who enrol and register and must be done as soon as possible in order to complete their personal file. Further information at:https://www.uc.pt/en/academicos/inscricoes/PIAs.

10. Other information:

- Application is subject to the payment of a $50.00 \in$ fee, which is non-refundable, even in case of invalidation of application and of non-placement.

- Applicants who do not have the documents attesting the required qualifications or other documents until the end of the deadline for applications may apply conditionally. If they do not submit the required documents until the new deadline provided, their application will become "Not Admitted". Then, they can move their application onto the following call for applications without any additional charges.

- In applications definitively considered valid, and after the evaluation period has started, it is not



possible to add or replace the documents presented. To add new documentation, a new application must be submitted in the next phase, if any.

- After the last phase of applications, and if there are still places available, applicants may submit their application by means of a request, beyond the deadline, which will be duly appraised by the coordination of the Course /Organisational Unit.
