4. Admission requirements:

Applicants for admission to this course must be:

- Young researchers, doctoral students, technicians, directors or other collaborators identified by the R&D Units of the UC Group, by the Organic Units or Administration Services of the University of Coimbra.

5. Selection criteria:

- a) Academic curriculum, [4/10 Weighting];
- b) Working experience, [4/10 Weighting];

c) Motivation, [2/10 Weighting].

NOTA: As candidaturas avaliadas que tenham nota inferior a 9,5 valores num dos critérios de avaliação serão automaticamente não admitidas.

6. Required documentation:

- 1- Motivation Letter; (MANDATORY);
- 2- Letter of Recommendation;
- 3- Identity Document (MANDATORY only for foreign applicants);
- 4- Updated and summarized curriculum, (not necessarily in Europass format); (MANDATORY).

NOTE: If the documents mentioned above are written in a foreign language other than Spanish, French, and English, it is mandatory to present a translation to Portuguese undertaken by a translator recognised by the Portuguese diplomatic representation.

- In applications definitively considered valid, and after the evaluation period has started, it is not possible to add or replace the documents presented. To add new documentation, a new application must be submitted in the next phase, if any.
