**1. Number of places:**

1st Call: 70 places

Extra call: remaining places

Note: A special quota of up to 30% of the places in the general contingent is reserved for applicants from schools in Brazil with which the University of Coimbra has a protocol or cooperation agreement and for applicants who have participated in activities or courses aimed at international students, namely, Universidade de Inverno, UC Diáspora and INSpire (see the list here: [https://www.uc.pt/brasil/uc-visita-brasil/acordo\\_escolas](https://www.uc.pt/brasil/uc-visita-brasil/acordo_escolas)). If the places reserved for this special quota are not taken, they will revert to the general quota.

**2. Minimum number of students for course opening:** Not applicable.

**3. Application deadlines:**

1st call: 13 December 2023 to 29 February 2024

2nd call: 18 March to 7 May 2024

3rd call: 15 May to 30 June 2024

Extra call: 8 July to 8 August 2024

**4. Admission requirements:**

To hold a Portuguese secondary education diploma or equivalent or a foreign education diploma that provides access to higher education in the country of origin.

NOTE: If the documents mentioned above are written in a foreign language other than Spanish, French, and English, it is mandatory to present a translation to Portuguese undertaken by a translator recognised by the Portuguese diplomatic representation.

- At the end of each application phase, the remaining places will be filled using the list of substitutes, if any, in accordance with the provisions of paragraph 2 of article 201 of the Academic

Regulation of the University of Coimbra.

- Enrolment and registration of International Students is only confirmed after a single payment corresponding to 25% of the total amount of the tuition fee, plus the registration fee, as provided for in paragraph 6 of article 201 of the Academic Regulation of the University of Coimbra.
- Application is subject to the payment of a fee in the amount of 50.00 €, non-refundable, including in cases of invalidation of application and non-placement.
