2. Minimum number of students for course opening: 6

3. Application deadlines:

1st call: 1st March to 1st April 2024 2nd call: 3rd June to 15th July 2024 3rd call: 2nd to 13th September 2024

4. Admission requirements:

1. Eligible candidates to this course include:

a) BA graduates or equivalent according to the principles of the European Space for Higher Education in the areas of Modern Languages, Cultures and Literatures, Art Studies, European Studies, History and Geography, among other areas of the Social Sciences and Humanities;b) Those with an educational, scientific or professional CV recognized by the official scientific authority of the University of Coimbra as showing competence to undertake this cycle of studies;

2. The applicants must ascertain their proficiency in two of the instruction languages of the consortium, equivalent to the C1 level of the Common European Framework of Reference for Languages (Portuguese, Spanish, German, French, Italian, Romanian) and knowledge of English language on the B2* level.

* Applicants on a proven B2 level in the instruction languages will be considered, along with other set of selection criteria, provided that they undertake to reach the C1 level before the confirmation of their registration and enrolment.

3. The recognition mentioned in b) is only effective when considered an entry requirement for this cycle of studies and cannot be understood as conferring the equivalence to a BA degree or to its recognition.

5. Selection criteria:

- a) Classification of Bahelor's degree or equivalent, [5/10 Weighting];
- b) Curriculum vitae, [3/10 Weighting];

c) Motivation letter, [2/10 Weighting].

Regarding the access referred to in sub-paragraph d) of paragraph 1 of the conditions of admission: The CV of applicants is rated on a scale of 0 to 20 in criteria i) to iv) and according to their respective weights:

i) Academic curriculum, considering the final classification of the degree(s) held, [25/100 Weighting];

ii) Relevance of the degree(s) held for the scientific area of the study cycle, [25/100 Weighting];

iii) Scientific curriculum, considering participation in congresses, seminars, research projects, number and scientific quality of publications (monographs, book chapters, articles in periodicals), prizes and similar awards, provided these activities are in the scientific area of the study cycle in question, [25/100 Weighting];

iv) Professional curriculum, considering the duration and nature of the professional activities performed in the scientific area of the study cycle in question, [25/100 Weighting].

NOTE: Assessed applications that have a grade lower than 9.5 in one of the evaluation criteria will automatically become non-approved.

- Certificate of Bachelor's degree with final course classification (diploma). A certificate proving approval in the curricular units carried out must be included, with respective classifications (school transcript). (MANDATORY, except if the primary course is a course taught at the University of Coimbra);

- Certificates attesting the proficiency in at least two European languages (C1) used in the Master's Degree Course as languages of instruction, as well as in English (B2, lingua franca); (MANDATORY);

- Curriculum Vitae; (MANDATORY);

- Identification document (MANDATORY only for foreign applicants);

- Motivation Letter; (MANDATORY);

- Official declaration of course outlines and hourly course loads with classification of each course unit of courses previously taken (transcript), in case of equivalence credits request (MANDATORY, except in degrees awarded by the University of Coimbra under the Bologna

Process - after 2007/2008);

- Official document certifying qualifications, issued by the institution awarding the degree, indicating the weighted average and the grading scale. (MANDATORY only for holders of a degree obtained abroad that does not contain the average).

NOTE: If the documents mentioned above are written in a foreign language other than Spanish, French, and English, it is mandatory to present a translation to Portuguese undertaken by a translator recognised by the Portuguese diplomatic representation.

The submission of the authenticated original documents is mandatory to the applicants admitted who enrol and register and must be done as soon as possible in order to complete their personal file. Further information at:https://www.uc.pt/en/academicos/inscricoes/PIAs.
