# 2nd cycle Master in Biotechnological Engineering

# 1. Number of places:

1st call: 5 places 2nd call: 30 places

3rd call: 10 places + remaining places

**2. Minimum number of students for course opening:** Not applicable.

### 3. Application deadlines:

1st call: 1st March to 1st April 2024 2nd call: 3rd June to 15th July 2024 3rd call: 2nd to 13th September 2024

#### 4. Admission requirements:

Applicants to the Master in Biotechnological Engineering must be:

- a) Holders of a Bachelor's degree or legal equivalent in Biotechnological Engineering, Biological Engineering, Chemical Engineering, Biochemical Engineering, Bioengineering, Biotechnology, Biochemistry, Biological Sciences, Industrial Chemistry, Chemical Technology, with courses organized according to the Bologna principles;
- b) Holders of a foreign higher academic degree, in the areas referred to in a) 1st cycle of studies organized according to the principles of the Bologna Process;
- c) Holders of a higher academic degree obtained abroad that is recognized by the Scientific Council of FCTUC as meeting the objectives of a bachelor degree in one of the referred areas;
- d) In duly justified cases, the holders of an academic, scientific or professional curriculum relevant



to the attendance of this study cycle and, as such recognized by the FCTUC Scientific Council, according to criteria approved by the referred council.

- 2. The recognition referred to in sub-paragraphs b) to d) of paragraph 1 merely provides access to the study cycle leading to the degree of master and does not confer on its holder the equivalence to the degree of bachelor or the recognition of that degree.
- 3 For applicants who do not speak Portuguese, proven knowledge of the English language with a minimum level of B1 (CEFR) or equivalent is required.

#### 5. Selection criteria:

Regarding access under a) to c) of point 1 of the admission conditions:

a) Assessment of the merit of applicants who are admitted under subparagraphs a) to c), (Weighting 5/6);

The evaluator evaluates the academic curriculum of the applicant, rating it on the scale of 0 to 20 according to criteria i) to iii) and their respective weightings, which are as follows:

- i) Final classification of the 1st cycle course held by the applicant (60%);
- ii) Vocational aptitude demonstrated by the adequacy of the objectives and contents of the previous studies to the objectives and contents of the course of application (30%);
- iii) Cross-cutting skills acquired in previous studies or in an extra-curricular environment (10%).
- b) Commitment to the new path. Motivation of the applicant towards the new academic path demonstrated through the motivation letter (Weighting 1/6);

Regarding access under point d) of point 1 of the admission conditions:

The evaluator evaluates the academic curriculum of the applicant, rating it on a scale of 0 to 20 according to criteria i) to iv) and their respective weightings, which are as follows:

- i) Academic curriculum, considering the final classification of the course (s) held by the applicant (40%);
- ii) Relevance of the course (s) held for the scientific area of the course of application (20%);
- iii) Scientific curriculum in the scientific area of the study cycle in question (20%);
- iv) Professional curriculum, considering the duration and nature of the professional functions performed in the scientific area of the study cycle in question (20%).

For applicants who do not speak Portuguese, proven knowledge of the English language with a minimum level of B1 (CEFR) or equivalent is required - exclusion criteria prevailing over all the previous ones.

**NOTE**: Assessed applications that have a grade lower than 9.5 in one of the evaluation criteria will automatically become non-approved.

# 6. Required documentation:



- Applicants from countries that do not speak Portuguese or English must provide proof of proficiency in English or Portuguese with a minimum level of B1 (CEFR) or equivalent; (MANDATORY, only for referred applicants);
- Certificate of Bachelor's degree with final course classification (diploma). A certificate proving approval in the curricular units carried out must be included, with respective classifications (school transcript). (MANDATORY, except if the primary course is a course taught at the University of Coimbra):
- Curriculum Vitae; (MANDATORY);
- Identification document (MANDATORY only for foreign applicants);
- Motivation Letter; (MANDATORY);
- Official declaration of course outlines and hourly course loads with classification of each course unit of courses previously taken (transcript), in case of equivalence credits request (MANDATORY, except in degrees awarded by the University of Coimbra under the Bologna Process after 2007/2008);
- Official document certifying qualifications, issued by the institution awarding the degree, indicating the weighted average and the grading scale. (MANDATORY only for holders of a degree obtained abroad that does not contain the average).

**NOTE**: If the documents mentioned above are written in a foreign language other than Spanish, French, and English, it is mandatory to present a translation to Portuguese undertaken by a translator recognised by the Portuguese diplomatic representation.

The submission of the authenticated original documents is mandatory to the applicants admitted who enrol and register and must be done as soon as possible in order to complete their personal file. Further information at:https://www.uc.pt/en/academicos/inscricoes/PIAs.

- Applicants who do not have the documents attesting the required qualifications or other documents until the end of the deadline for applications may apply conditionally. If they do not submit the required documents until the new deadline provided, their application will become "Not Admitted". Then, they can move their application onto the following call for applications without any additional charges.
- In applications definitively considered valid, and after the evaluation period has started, it is not possible to add or replace the documents presented. To add new documentation, a new application must be submitted in the next phase, if any.
- After the last phase of applications, and if there are still places available, applicants may submit their application by means of a request, beyond the deadline, which will be duly appraised by the coordination of the Course /Organisational Unit.
