- Have completed secondary or equivalent education or are able to complete it in the academic year in which they apply to the course.

#### 5. Selection criteria:

Literary Qualification: A) If they have completed secondary education or an equivalent level in the year prior to the application; B) If they attend the 12th curricular year of the secondary education, or an equivalent curricular year. [20/20 Weighting].
