Applicants to the access and admission to the course may be:

- Individuals who hold a bachelor's, master's or doctor's degree;

- Individuals who hold the extinct courses of the Primary Magisterium, of Childhood Educators and of General Nursing and also a secondary education course, a complementary course to the secondary education or the 10th / 11th grade of secondary school;

- Individuals who are not covered by the status of International Student that is ruled by Decree-Law no. 36/2014 of 10th March, in its current wording.

NOTE: Applicants of Portuguese nationality or equivalent, with a higher academic degree obtained abroad, can apply as long as they hold a degree and diploma recognition.

(MANDATORY, except in degrees obtained at the University of Coimbra);

3-Transcript detailing subjects studied (ECTS or hours) and grade per subject (MANDATORY, except in degrees obtained at the University of Coimbra);

4- Workload and programmes of curricular units if credits are to be requested (MANDATORY, except in degrees awarded by the University of Coimbra under the Bologna Process – after 2007/2008).

5- Curriculum Vitae; (MANDATORY);

6- Identity Document (MANDATORY, only for foreign applicants).

NOTE: If the documents mentioned above are written in a foreign language other than Spanish, French, and English, it is mandatory to present a translation to Portuguese undertaken by a translator recognised by the Portuguese diplomatic representation.
