#### 2. Minimum number of students for course opening: Not applicable

#### **3.** Application deadlines:

1st call: 31st May to 1st July 2024 2nd call: 16th September to 3rd October 2024

#### 4. Admission requirements:

Applicants to the access and admission to the course may be:

- Individuals who do not hold academic qualifications to apply to higher education;

- Individuals who have successfully accomplished the over 23 years old Specially Adequate Exam intended to assess their Ability to attend Higher Education that is valid for the course to which they want to apply;

- Individuals who meet the Prerequisite: Group D - Vision capacity.

Documentation required: Declaration on oath, according to Annex VI of Deliberation no. 316/2024 of 13th March, required at the time of enrollment and registration, without which enrolment and

registration is not possible;

- Individuals who are not covered by the status of International Student that is ruled by Decree-Law no. 36/2014 of 10th March, in its current wording.

#### 5. Selection criteria:

- Classification of the specially adapted exam to assess the capacity to attend higher education for students over 23, [10/10 Weighting].

## 6. Required documentation:

1 - Motivation Letter (MANDATORY);

2 - Identification document (MANDATORY, only for foreign applicants);

3 - Transcript detailing subjects studied (ECTS or hours) and grade per subject (MANDATORY, except in degrees obtained at the University of Coimbra);

4 - Workload and programmes of curricular units if credits are to be requested (MANDATORY, except in degrees awarded by the University of Coimbra under the Bologna Process – after 2007/2008).

NOTE: If the documents mentioned above are written in a foreign language other than Spanish, French, and English, it is mandatory to present a translation to Portuguese undertaken by a translator recognised by the Portuguese diplomatic representation.

The submission of the authenticated original documents is mandatory to the applicants admitted who enrol and register and must be done as soon as possible in order to complete their personal file. Further information at:https://www.uc.pt/en/academicos/inscricoes/PIAs.
