4. Admission requirements:

Applicants to the access and admission to the course may be:

- Individuals who do not hold academic qualifications to apply to higher education;
- Individuals who have successfully accomplished the over 23 years old Specially Adequate Exam intended to assess their Ability to attend Higher Education that is valid for the course to which they want to apply;
- Individuals who meet the Prerequisite: Group B - Interpersonal communication.

Documentation required: Medical statement, according to Annex IV of Deliberation No.

316/2024 of 13th March, proving that the applicant meets the prerequisite required at the time of

enrollment and registration, without which enrolment and registration is not possible;

- Individuals who are not covered by the status of International Student that is ruled by Decree-Law no. 36/2014 of 10th March, in its current wording.

5. Selection criteria:

- a) Classification of the specially adapted exam to assess the capacity to attend higher education for students over 23, [2/3 Weighting];
- b) Year in which the approval has been obtained, priority being given to applicants that have obtained it first, [1/3 Weighting].

6. Required documentation:

- 1 - Motivation Letter (MANDATORY);
- 2 - Identification document (MANDATORY, only for foreign applicants);
- 3 - Transcript detailing subjects studied (ECTS or hours) and grade per subject (MANDATORY, except in degrees obtained at the University of Coimbra);
- 4 - Workload and programmes of curricular units if credits are to be requested (MANDATORY, except in degrees awarded by the University of Coimbra under the Bologna Process – after 2007/2008).

NOTE: If the documents mentioned above are written in a foreign language other than Spanish, French, and English, it is mandatory to present a translation to Portuguese undertaken by a translator recognised by the Portuguese diplomatic representation.

The submission of the authenticated original documents is mandatory to the applicants admitted who enrol and register and must be done as soon as possible in order to complete their personal file. Further information at: <https://www.uc.pt/en/academicos/inscricoes/PIAs>.
