**Integrated Master's in Dentistry**

**1. Number of places:**

1st call:

1st year: 0 place

Remaining years: 5 places

**2. Minimum number of students for course opening:** Not applicable.

**3. Application deadlines:**

1st call: 1st July to 16th August 2024

**4. Admission requirements:**

1 - Students that request institution / course transfer must meet the following conditions:

- a) To have been enrolled and registered in another institution / course, not having completed that course;
  - b) To have taken, in any previous school year, the national secondary education exams established for the course of application for the 2024/2025 academic year under the national higher education call (One of the following sets: (02) Biology and Geology + (07) Physics and Chemistry or (02) Biology and Geology + (19) Mathematics);
  - c) To have obtained in these exams the minimum classification required by the University of Coimbra, in the academic year 2024/2025, under the general access regime (Entry exams: 140 points out of 200).
- 2 - The institution / course transfer applies equally to students who have been enrolled and registered in a foreign higher education institution in a course defined as a higher education course

by the legislation of the country of the higher education institution, and who have not completed it.

3 - For students who hold non-Portuguese courses legally equivalent to Portuguese secondary education, the condition established by paragraph 1 may be fulfilled through the application of article 20-A of Decree-Law No. 296-A / 98, of September 25, in its updated form.

4 - For students who have enrolled in higher education through specially adapted tests to students over 23 years of age, the condition of admission laid down in paragraph 1 (b) and (c) may be replaced by the exams established for the course of application, for the 2024/2025 academic year, within the scope of the National Higher Education Call, as long as authorized by the Scientific Committee of the Faculty of Medicine the University of Coimbra. In order to submit the authorization request applicants must:

- file a request to the President of the Scientific Committee of the Faculty of Medicine before the end of the application deadline explaining the reasons for the request for [ccientifico@fmed.uc.pt](mailto:ccientifico@fmed.uc.pt) (preferably manually signed);

5 - For international students, the condition established by paragraph 1 (b) and (c) may be replaced by the exams established for the course of application, for the 2024/2025 academic year, within the scope of the Special Access Competition.

6- The exams referred to in paragraph 1 (b) and 3 may have been taken in any school year.

7 - The transfer to an institution / course for which, according to the national higher education call, specific prerequisites or vocational skills are required, is conditioned to meeting these prerequisites. Prerequisite: Group A - Interpersonal communication.

Documentation required: Medical statement, in the form of a questionnaire, pursuant to the regulation published as Annex III of Deliberation n.º 316/2024, of 13 march, proving that the applicant meets the prerequisite required at the time of enrollment and registration, without which enrolment and registration is not possible.

## 5. Selection criteria:

a) Average of classifications of the national access competition exams set for access to the desired degree/institution, for the year 2024/2025, under the general access regime or the average of classifications of the exams used in the cases mentioned under 3, 4 and 5 of point 4 of this notice, [4/10 Weighting];

b) Motivation for the new academic course, considering the vocational aptitude shown by the consonance between the training goals and the goals of the degree to which the applicant aspires to. The motivation letter is the deciding factor in the cases when two or more applicants are competing for the last place available, [1/10 Weighting];

c) Course of origin and number of ECTS: [5/10 Weighting].

- Having completed an Integrated Master's course in Dentistry, or equivalent, with between 120 and 155 ECTS - 20 points;

- Have attended an Integrated Master's course in Dentistry, or equivalent, with less than 120 ECTS or more than 155 ECTS - 10 points;
- Applicants from other higher education courses - 5 points.

## 6. Required documentation:

- Declaration on honour (download), signed by the applicant, stating that he/she has not the Portuguese nationality, nor falls under any of the conditions that prevent him/her from applying to this competition, and that he/she has the necessary degree programme pre-requisites (when applicable). Self-declaration should be manually signed as identity document;
- Document that proves that the applicant sat for the exams and obtained the minimum grades required in the national access call exams/specific exams set for the degree to which he/she is applying (known as “Ficha ENES”) or the document that replaces it, in accordance with 3, 4 and 5 of number 4 of the present notice of opening; (MANDATORY);
- Document that proves that the candidate stills hold the right to enroll at University in the academic year to which he/she is applying, in the case of a candidate that was enrolled, in the previous academic year, in a Portuguese higher institution other than the University of Coimbra; (MANDATORY, except for students of the UC and candidates from foreign universities);
- Document that proves that the candidate was/is enrolled in a higher education institution and did not complete the degree at the basis of this application; (MANDATORY, except for students and ex-students of the UC);
- Identification document (MANDATORY only for foreign applicants);
- Motivation Letter; (MANDATORY);
- Transcript detailing subjects studied (ECTS or hours) and grade per subject (MANDATORY, except in degrees obtained at the University of Coimbra);
- Workload and programmes of curricular units if credits are to be requested (MANDATORY, except in degrees awarded by the University of Coimbra under the Bologna Process – after 2007/2008).

**NOTE:** If the documents mentioned above are written in a foreign language other than Spanish, French, and English, it is mandatory to present a translation to Portuguese undertaken by a translator recognised by the Portuguese diplomatic representation.

The submission of the authenticated original documents is mandatory to the applicants admitted who enrol and register and must be done as soon as possible in order to complete their personal file. Further information at: <https://www.uc.pt/en/academicos/inscricoes/PIAs>.

**10. Other information:**

- Application is subject to the payment of a 50EUR fee, which is non-refundable, even in case of invalidation of application and of non-placement.
- Registration and enrollment of International Students is only confirmed after a single payment corresponding to 25% of the total tuition fee, plus the application fee.

- Applicants who do not have the documents attesting the required qualifications or other documents (except for FICHA ENES and the document that proves that the applicant did not complete the degree) until the end of the deadline for applications may apply conditionally. If they do not submit the required documents until the new deadline provided, their application will become "Not Admitted" in the final ranking list.
- In applications definitively considered valid, and after the evaluation period has started, it is not possible to add or replace the documents presented.
- After the last phase of applications, and if there are still places available, applicants may submit their application by means of a request, beyond the deadline, which will be duly appraised by the coordination of the Course /Organisational Unit.
