4. Admission requirements:

Students may be readmitted to this course if they:

- a) Have already been enrolled and registered in that same course at the University of Coimbra;
- b) Have not been registered in that course in the previous school year to which they intend to be readmitted in, even if they have dropped out in that school year.

5. Selection criteria:

- Not applicable.

6. Required documentation:

- Certificate proving approval in the curricular units taken, including the respective grades, as well as the workload and programs of the curricular units completed in the original course (MANDATORY if you are seeking credit transfer and the original course was not taught at the University of Coimbra);
- Identification document (MANDATORY only for foreign applicants);
- Motivation Letter; (MANDATORY).

7. Tuition fee:

- National Student or equivalent: 1,250 EUR (annual fee);
- International student: 7,000 EUR (annual fee).

RRP (Recovery and Resilience Plan) Support to the Tuition Fee*:

- 50 per cent of support to the tuition fee payment for national students.
- 40 per cent of support to the tuition fee payment for International Students.
