**Master's Degree in Social Intervention, Innovation and Entrepreneurship**

**1. Number of places:**

1st call: 10 places

2nd call: 15 places

3rd call: 5 places + remaining places

**2. Minimum number of students for course opening: 8**

**3. Application deadlines:**

1st call: 2nd to 31st March 2026

2nd call: 1st June to 15th July 2026

3rd call: 1st to 11th September 2026

**4. Admission requirements:**

1. Applicants to the cycle of studies leading to this Master's degree must be:

- a) Holders of a bachelor's degree or legal equivalent, namely in scientific fields similar to the study field of the Master's degree;
- b) Holders of a foreign higher academic degree awarded following a 1st cycle of studies organized according to the principles of the Bologna Process by a State compliant with this Process;
- c) Holders of a foreign higher education academic degree recognized as meeting the objectives of a Bachelor's degree by the Scientific Council responsible for the Master's cycle of studies;
- d) In duly justified cases, holders of a scientific and professional curriculum relevant for completing this cycle of studies as recognized by the Scientific Committee of Psychology and Education Sciences.

2. The recognition referred to in sub-paragraphs b) to d) of paragraph 1 merely provides access to the study cycle leading to the degree of master and does not confer on its holder the equivalence to the degree of bachelor or the recognition of that degree.

3 – Concerning the applications done according to the subparagraphs (c) to (e) of paragraph 1, the recognition by the Scientific Council of the FPCE-UC, of the academic, scientific or professional curriculum that attests the ability to accomplish this cycle of studies must be requested before the submission of the application. Otherwise, the applicant will be excluded due to failure to comply with the conditions of admissibility. Such a request must be sent no later than one month before the beginning of the applications period, except for the 1st phase in which the request may be done until 10 days before the end of the applications deadline, to [cc@fpce.uc.pt](mailto:cc@fpce.uc.pt).

1.1 Academic CV, [3/10 Weighting];

Bachelor's degree (the score assigned is the same as the final grade of the course provided that it meets the criteria expressed in the access conditions: undergraduate courses related to the field of study of the master's programme).

1.2 Academic CV, [2/10 Weighting];

Other academic training (in other academic training, the attendance (with or without conclusion) of postgraduate courses and training courses relevant to the strategic areas of the master's programme will be evaluated).

1.3 Academic Curriculum, [2/10 Weighting];

Assessment of the number of publications, communications and organisation of scientific or technical meetings and, also, the experience of participation in social research projects

2. Professional CV, [2/10 Weighting];

Assessment of professional merit focused on the experience shown in the application in functions performed in social intervention projects or programmes

3. Motivation: Applicant's Profile, [1/10 Weighting].

### **2nd Cycle - Application based on Subparagraph d)**

1.1 Academic CV, [3/10 Weighting];

Bachelor's degree (the score assigned is the same as the final grade of the course provided that it meets the criteria expressed in the access conditions: undergraduate courses related to the field of study of the master's programme).

1.2 Academic CV, [2/10 Weighting];

Other academic training (in other academic training, the attendance (with or without conclusion) of postgraduate courses and training courses relevant to the strategic areas of the master's programme

will be evaluated).

1.3 Academic CV, [2/10 Weighting];

Evaluation of the number of publications and participation in scientific meetings and the experience with social research projects.

2. Professional CV, [2/10 Weighting];

Assessment of professional merit focused on the experience shown in the application in functions performed in social intervention projects or programmes.

3. Motivation: Candidate's profile, [1/10 Weighting].

**NOTE:** Assessed applications that have a grade lower than 9.5 in one of the evaluation criteria will automatically become non-approved.

#### **6. Required documentation:**

- Certificate of Bachelor's degree with final course classification (diploma). A certificate proving approval in the curricular units carried out must be included, with respective classifications (school transcript). (MANDATORY, except if the primary course is a course taught at the University of Coimbra);
- Curriculum Vitae; (MANDATORY);
- Document attesting the capacity to complete the study cycle [applications made under paragraph c) and d)]; (MANDATORY, only for applicants applying under point 3 of the admission conditions);
- Identification document (MANDATORY only for foreign applicants);
- Motivation Letter; (MANDATORY);
- Official declaration of course outlines and hourly course loads with classification of each course unit of courses previously taken (transcript), in case of equivalence credits request (MANDATORY, except in degrees awarded by the University of Coimbra under the Bologna Process – after 2007/2008);
- Official document certifying qualifications, issued by the institution awarding the degree, indicating the weighted average and the grading scale. (MANDATORY only for holders of a degree obtained abroad that does not contain the average).

**NOTE:** If the documents mentioned above are written in a foreign language other than Spanish, French, and English, it is mandatory to present a translation to Portuguese undertaken by a translator recognised by the Portuguese diplomatic representation.

The submission of the authenticated original documents is mandatory to the applicants admitted who enrol and register and must be done as soon as possible in order to complete their personal file. Further information at: <https://www.uc.pt/en/academic-services/submit-docs/>.

**10. Other information:**

- Application is subject to the payment of a 50.00 € fee, which is non-refundable, even in case of invalidation of application and of non-placement.

- Applicants who do not have the documents attesting the required qualifications or other documents until the end of the deadline for applications may apply conditionally. If they do not submit the required documents until the new deadline provided, their application will become "Not Admitted". Then, they can move their application onto the following call for applications without any additional charges.
- In applications definitively considered valid, and after the evaluation period has started, it is not possible to add or replace the documents presented. To add new documentation, a new application must be submitted in the next phase, if any.
- After the last phase of applications, and if there are still places available, applicants may submit their application by means of a request, beyond the deadline, which will be duly appraised by the coordination of the Course /Organisational Unit.
