**4. Admission requirements:**

Students may be readmitted to this course if they:

- a) Have already been enrolled and registered in that same course at the University of Coimbra;
- b) Have not been registered in that course in the previous school year to which they intend to be readmitted in, even if they have dropped out in that school year.

**5. Selection criteria:**

**6. Required documentation:**

1 - Motivation Letter [MANDATORY];

- 2 - Certificate proving approval in the curricular units taken, including the respective grades, as well as the workload and programs of the curricular units completed in the original course [MANDATORY if you are seeking credit transfer and the original course was not taught at the University of Coimbra];
- 3 - Identification document [MANDATORY only for foreign applicants].

NOTE: If the documents mentioned above are written in a foreign language other than Spanish, French, and English, it is mandatory to present a translation to Portuguese undertaken by a translator recognised by the Portuguese diplomatic representation.
